GOVERNMENT NOTIFICATIONS.

THE FOOD CONTROL ORDINANCE.

Order No. 71.

BY virtue of the powers vested in me by section 4 (1) (d) of the Food Control Ordinance (Chapter 132), read with the Defence (Food and Price Control) (Transfer of Powers) Regulations, 1942, I, Don Stephen Senanayake, Minister for Agriculture and Lands, do by this Order prohibit the removal from the Customs premises at any port or place mentioned in the first column of the Schedule hereto, of any rice, paddy, wheat, wheat flour or kurakkan which is imported into Ceylon, except under a permit issued by the person mentioned in the corresponding entry in the second column of that Schedule, and except in accordance with such directions as he may issue in regard to the time at which, the manner in which and the place to which such rice, paddy, wheat, wheat flour or kurakkan may be so removed.

THE FOOD CONFROL ORDINANCE.

Order No. 73.

BY virtue of the powers vested in me by section 4 (1) (g)of the Food Control Ordinance (Chapter 132), read with the Defence (Food and Price Control) (Transfer of Powers) Regulations, 1942, I, Don Stephen Senanayake, Minister for Agriculture and Lands, do by this Order direct the Food Controller to take steps for the allocation of supplies of paddy or other grain or any preparation made mainly or wholly from such grain to merchants and distributors in all parts of Ceylon and to organize and administer a system of rationing such supplies on and after the date hereof.

'REDUCTION OF PROPRIETORS' AND DEALERS' STOCKS.

By virtue of the powers vested in me by Regulation 2 of the Defence! (Authorised Stocks of Rubber) Regulations, published in the *Ceylon Government Gazette* No. 9,255 of April 5, 1944, it is hereby notified that until further notice—

(i.) the proprietor of a rubber estate or small-holding shall not, at any time during the year, have in his possession or under his control stocks of rubber exceeding one-eighth of the amount of the Standard Production of such estate or small-holding, as the case may be, last determined under the provisions of the Rubber Control Ordinance, No. 63 of 1938;
(ii.) the total, quantity of subber in the possession of or under the control of a registered dealer (other than an approved shipper) shall not at any time during the year exceed one half of the authorised stock of such dealer for 1944.
