NOTICE is hereby given that the Government Agent of the Westorn Province (hereinafter referred to as the Government Agent) will receive tenders for the purchase of the lease of the Crown lund described in the First Schedule hereto, subject to the conditions specified in the Second Schedule hereto, for a term of two years commencing from October 1, 1944 commencing from October 1, 1944.

First Schedule.

1. 2. The person making the tender shall specify therein the monthly rental which he is prepared to pay in respect of the lease.

3. The Government Agent may, on the date on which the tenders are opened, call upon the successful tenderer to deposit a sum not exceeding five hundred (500) Rupees. In the event of such tenders's failing to do so, his tender will be rejected.
4. The person whose tender is accepted shall execute a lease within fourteen days of its being presented to him. In the event of his failure to do so, the Government Agent may cancel the sale and confiscate any deposit paid by the tenderer.
5. The proposed lease will contain the following conditions (amongst others):—

- (a) the lessee shall pay the monthly rent in advance at the Colombo Kachcheri on or before the first day of each month,

 (b) the lessor (or the Government Agent on his behalf) or the lessee may terminate the lease at any time on giving six months' notice in writing to the other party;
 (c) the lessee shall bear, pay and discharge all existing and future rates, taxes, assessments and outgoings whatsoever in respect of the demised premises;
 (d) the lessee may cultivate grass and vegetables upon the demised premises; but shall not plant any shrubs, plants or trees thereon or to utilize the land for any other purpose

except with the consent of the Government Agent previously obtained in writing;

- (e) the lessee or his workmon shall not cut down any trees that are on the land, nor interfere with any existing fence or
- (f) the lessee shall keep the land clean and in good order in conformity with Urban Council Regulations applicable to the land :
