THE CONTROL OF PRICES ORDINANCE, NO. 39 OF 1939. Order.

By virtue of the powers vested in the Controller of Prices by section 3 of the Control of Prices Ordinance, No. 39 of 1939, as amended by paragraph (2) of the Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Cedric Francis Ingledow, Controller of Prices (Miscellaneous Articles), do, by this Order-

- (i) revoke with effect from this date Price Order dated September 11, 1944, published in Government Gazette No. 9,311 of September 15, 1944;
- (ii.) fix the prices specified in columns 2, 3 and 4 of the Schedule hereto to be, respectively, the manufac-turer's maximum price to a wholesale dealer, the maximum wholesale price and the maximum retail price above which tooth paste of the description and size specified in column 1 of the Schedule shall not be sold in any part of Ceylon ; (iui.) direct that for the purpose of this Order---

- (a) any sale for the purpose of resale of the tooth paste referred to in the Schedule shall be deemed to
- be a sale by wholesale;
  (b) any sale for the purpose of use of the tooth paste referred to in the Schedule shall be deemed to be a sale by retail;
- (iv.) direct that every person, who sells any tooth paste specified in column 1 of the Schedule hereto, shall give to every purchaser of such tooth paste, on demand, a receipt there shall be set out-(a) the quantity, description and size of the tooth

- (d) the nature of the transaction, that is to say, whether the transaction was by wholesale or by retail ;
- (v.) direct that any trader, who, at any premises in Ceylon, sells any tooth paste of the description and size specified in the Schedule hereto, shall exhibit in a conspicuous position at those premises a notice on which there shall be set out the maximum prices fixed by this Order in respect of tooth paste of that description and size.
