THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

DEFENCE regulation made by the Governor by virtue of the powers vested in him by the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament, as adapted, modified and extended to Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940.

The Defence (Machine Tools) Regulations, 1942, published in Gazette Extraordinary No. 8,978 of July 29, 1942, as amended by the Defence Regulation published in Gazette No. 9,024 of October 23, 1942, are hereby further amended as follows :-

- (1) in regulation 2, in the definition of "Director", by the substitution, for the words "Director of Engineering Production ", of the words "Production Engineer, Engineering Production Department"; and
- (2) by the rescission of regulation 6.

ORDER made by the Governor by virtue of the powers vested in him by regulation 43D of the Defence (Miscellaneous) Regulations.

1. This Order may be cited as the Controlled Articles (Electric Machines) Order, 1945.

4. No person shall sell, transfer or otherwise dispose of any electric machine of any description specified in the Schedule to any other person except upon the surrender to him by that other person of a permit authorising that other person to purchase or otherwise acquire an electric machine of that description.

Every application for a permit under this Order shall be made to the Chief Engineer and shall be in such form as may be approved by him for the purpose.

- 6. The Chief Engineer may in his discretion-
- (a) refuse to issue a permit under this Order to any applicant therefor;
- (b) determine and specify in any permit the terms and conditions subject to which the permit is issued. ;

7. Every person to whom a permit is issued under this Order shall comply with the terms and conditions, if any, specified in the permit.

8. _Every dealer shall---

- (a) keep and maintain in such form as may be approved by the Chief Engineer, such records relating to stocks of electric machines imported, held, purchased, acquired, sold, used, or otherwise disposed of by such dealer as the Chief Engineer may from time to time require for the purposes of this Order;
 (b) furnish to the Chief Engineer at the end of each month
- (b) furnish to the Chief Engineer at the end of each month such returns or other information relating to such stocks as the Chief Engineer may require for the purposes of this Order.

9. Every application and every return made under this Order shall be verified by a declaration, signed by the person making such application or return, to the effect that the particulars contained therein are true and accurate.

*10. In these regulations-

- "Chief Engineer" means the Chief Engineer and Manager of the Department of Government Electrical Undertakings;
- "dealer" means a person who imports electric machines into Ceylon for the purpose of trade or who carries on any business whether wholesale or retail as a seller or supplier of electric machines, and includes any person who carries on such business together with any other business; "electric machine" means a machine of any description
- "electric machine" means a machine of any description specified in the Schedule; "permit" means a permit issued by the Chief Engineer
- "permit" means a permit issued by the Chief Engineer under this Order.

THE DEFENCE (MISCELLANEOUS) REGULATIONS.

Appointment of Competent Authority.

BY virtue of the powers vested in me by regulation 3 of the Defence (Miscellaneous) Regulations, I, Henry Monck-Mason Moore, Governor of Ceylon, do hereby—

(1) appoint the Production Engineer, Engineering Production Department, to be the competent authority for the whole Island for the purpose of exercising and discharging the powers and functions conferred by regulation 43A of those Regulations in relation to all engineering production undertakings for the time being declared by Order to be controlled undertakings for the purposes of the aforesaid regulation 43A, subject however to the condition that no such powers or functions shall be exercised or discharged by the Production Engineer, Engineering Production Department, except in accordance with such general or special directions as may be issued to him in that behalf by the Minister for Communications and Works;

(2) revoke the appointment of the Chairman, Engineering Production Board, as a competent authority for the purposes of regulation 43A of the Defence (Miscellaneous) Regulations, and referred to in the notification published in Gazette No. 9,152 of July 30, 1943.

THE DEFENCE (MISCELLANEOUS) REGULATIONS.

Appointment of Competent Authority.

BY virtue of the powers vested in mo by regulation 3 of the Defence (Miscellaneous) Regulations, I, Henry Monck-Mason Moore, Governor of Ceylon, do hereby appoint the Production Engmeer, Engineering Production Department, to be the competent authority for the whole Island for the purpose of requisitioning under regulation 37 of those Regulations any article specified or described in item 9 of Part I of the Schedule to the Notification under the said regulation 3 published in *Gazette* No. 9,066 of January 15, 1943, as amended by the notification published in *Gazette* No. 9,152 of July 30, 1943, and accordingly the said item 9 shall be amended in column I thereof by the substitution, for the words "Chairman, Engineering Production Board", of the words
