BY virtue of the powers vested in the Governor by regulation 3 of the Defence (Control of Imports) Regulations, I, Henry Monck-Mason Moore, Governor of Ceylon, do by this Order amend the Schedule to the Order under that regulation published at page 3 of the Supplement to Gazette No. 8,776 of August 1, 1941 (as amended by any subsequent Order), by the substitution for item 36, of the following new item:—

"36. Coir manufactures other than coir yarn .. III-M"
