## GOVERNMENT NOTIFICATIONS.

THE CONTROLLED ARTICLES (RUBBER TYRES AND TUBES) (No. 2) ORDER, 1942.

Notice directing the furnishing of returns relating to tyres.

BY virtue of the powers vested in me by paragraph 15k of the Controlled Articles (Rubber Tyres and Tubes) (No. 2) Order, 1942, as amended by Order published in Gazette No. 9,373 of February 23, 1945, I, Herman Eric Peries, Tyre Controller, do by this notice, direct—

(a) that every person who on the date of publication of this notice is the registered owner of a motor car shall furnish to me within fourteen days after that date, and

(b) that every person who on any day after that date becomes the registered owner of a motor car shall furnish to me within fourteen days after that day,

a return specifying-

(i.) the name and address of the registered owner, (ii.) the distinctive number of the motor car, and

(iii.) the name of the manufacturer, the size, and any serial or other number, marked or embossed on each of the tyres possessed by the registered owner and used or intended to be used on the motor car.

## 2. In this notice-

"motor car" includes a motor cycle and a motor van not fitted with giant tyres, but does not include an omnibus, or a lorry (whether a trailer or a tractor or a motor hearse or a motor ambulance or any other kind of lorry other than a motor van not fitted with giant tyres);

"registered owner", with reference to a motor car, means the person registered as the owner of that car under the Motor Car Ordinance, No. 45 of 1938; and "distinctive number", with reference to a motor car, means the distinctive number assigned to that car under

section 16 of the Motor Car Ordinance, No. 45 of 1938.

Note.—(1) A person who furnishes a return which to his knowledge is untrue or incorrect commits an offence punishable under Regulation 43D (2) of the Defence (Miscellaneous) Regulations, with a fine not exceeding one thousand rupees or with imprisonment of either description for a term not exceeding six months, or with both such fine and imprisonment.

(2) No printed form for making the return will be supplied by this Department.
