THE REVENUE PROTECTION ORDINANCE.

Order under Section 2.

THE following Order made by the Governor in pursuance of the powers vested in him by Section 2 of the Revenue Protection Ordinance is hereby published for information.

THE REVENUE PROTECTION ORDINANCE.

Order under Section 2.

Whereas I, Henry Monck-Mason Moore, Governor of Ceylon, have, during the present session of the State Council, approved of the introduction into that Council of a bill

357—J. N. A 49134-2,045 (3/45)

whereby, if such bill be passed into law, export duty on the goods specified in column I of the Schedule hereto shall continue to be levied at the increased rates which came into force on the tenth day of July, 1941 :

Now, therefore, in pursuance of the powers vested in me by section 2 of the Revenue Protection Ordinance (Chapter 191), I do hereby order the Principal Collector of Customs to continue from midnight of 20th/21st March, 1945, to demand and levy upon the goods specified in column I of the Schedule hereto the corresponding export duties severally set out in column II of that Schedule.

Order.

The Colombo (Fishing Vessels) Navigation Order, 1943, published in *Gazette* No. 9,106 of April 2, 1943 (as amended by any subsequent Order) is hereby further amended by the substitution, for the Schedule to that Order, of the following new Schedule:—

** Schedule.*

1. The whole of the hatched area depicted in the sketch X set out in this Schedule and bounded as follows:—
 - (a) By a line drawn from the conical buoy with red and white vertical stripes (marked A in the sketch, in position 285 degrees 1.4 miles from the Fixed Red Light on the outer end of the South West breakwater) in a 331 degree direction 1 mile to a conical buoy with red and white vertical stripes in position B in the sketch, continuing in the same direction 1.2 miles to a can buoy with red and white vertical stripes in position C in the sketch;
 - (b) thence in a 058 degree direction 1.6 miles to a can buoy with red and white vertical stripes in position D in the sketch, continuing in the same direction 1.8 miles to a black conical buoy in position E in the sketch, continuing in the same direction .6 of a mile to a point on the coast marked F in the sketch;
 - (c) thence the line of the coast 2.5 miles to a point on the coast marked G in the sketch;
 - (d) thence in a 241 degree direction .8 of a mile to a conical buoy with red and white horizontal stripes in position H on the sketch continuing in the same direction to A.
2. The whole of the hatched area depicted in the sketch Y set out in this Schedule and bounded as follows:—
 - (a) By a line drawn from the point (marked J in the sketch) on the western end of the Fishing Harbour Mole in a 010 degree direction distant .65 of a mile to a white spar buoy at the point marked K in the sketch;
 - (b) thence by a line drawn in a 090 degree direction to the point marked L on the coast;
 - (c) thence the line of the coast from point L to point J.
