THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND (1940.

DEFENCE Regulations made by the Governor by virtue of the powers vested in him by the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament, as adapted, modified and extended to Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940.

By His Excellency's command,

Sent a Colombo, 12 October, 1945. Regulations.

1. These regulations may be cited as the Defence (Ceylon Standard Time) Regulations, 1945.

2. On October 15, 1945, at 2 A.M. according to the time prescribed for general purposes in Ceylon by the Defence (Daylight Saving) Regulations, 1942, the time shall be 1 A.M., and thereafter the time for general purposes in Ceylon shall

be Ceylon Standard Time.

In this Regulation, "Ceylon Standard Time" means the time declared by notification dated May 29, 1905, and published in Gazette No. 6,055 of June 2, 1905, to be adopted for Ceylon, that is to say, five hours and thirty minutes in advance of Greenwich Mean Time.

3. Wherever any reference to a point of time on or after October 15, 1945, occurs in any enactment, Order in Council, Ordinance, or other written law, or in any deed, time table, notice, advertisement or other document whatsoever, the time referred to shall be deemed, subject as hereinafter provided, to be the time as fixed for general purposes by regulation 2 of these Regulations:

Provided that nothing in the preceding provisions of these Regulations shall affect the use of time other than the time prescribed by regulation 2 for the purposes of astronomy, meteorology or navigation, or affect the construction of any document mentioning or referring to time in connexion with any of those purposes.
