FINAL ORDERS.

LAND SETTLEMENT ORDINANCE.

Settlement Order No. 824 (Kurunegala).

WHEREAS a settlement notice under section 4 of the Land Settlement Ordinance, was duly published in the Gazette No. 8,225 of June 19, 1936, and as otherwise required by the said section, in respect of the lands situated in the village of Siyambalangomuwa, in the Ihala Otota korale of the Hiriyala hatpattu of the Kurunegala District, in the North-Western Province, and described as lots 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17 and 18 in block survey preliminary plan No. 2,820 (vide Settlement Notice No. 1,285):
