RICE, WHOLE WHEAT, WHEAT FLOUR AND BAJIRI (CAMBU).

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Order.

BY virtue of the powers vested in the Deputy Controller of Prices (Food), by section 3, read with section 2 (3), of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Cathiravelu Sittampalam, Deputy Controller of Prices (Food) for the Matale District, do, by this Order—

- (i.) fix the price specified in column 2 of the Schedule hereto to be the maximum retail price per measure above which Rice shall not be sold in the area mentioned in the corresponding entry in column 1 in the Schedule hereto;
- (ii.) fix the price specified in column 3 of the Schedule hereto to be the maximum retail price per measure above which Whole Wheat shall not be sold in the area mentioned in the corresponding entry in column 1 in the Schedule hereto;
- (iii.) fix the price specified in column 4 of the Schedule hereto to be the maximum retail price per pound above which Wheat Flour shall not be sold in the area mentioned in the corresponding entry in column 1 in the Schedule hereto;
- (iv.) fix the price specified in column 5 of the Schedule hereto to be the maximum retail price per measure above which Bajiri (Cambu) shall not be sold in the area mentioned in the corresponding entry in column 1 in the Schedule hereto;
- (v.) direct that every trader who has in his possession Rice, Whole Wheat, Wheat Flour or Bajiri (Cambu) in the area mentioned in column 1 of the Schedule hereto, shall exhibit in a conspicuous position at his premises (store or boutique) a notice in which shall be set out the maximum price for Rice, Whole Wheat, Wheat Flour and Bajiri (Cambu) fixed by this Order;
- (vi.) direct that every person who sell Rice, Whole Wheat, Wheat Flour or Bajiri (Cambu), shall on demand, give the purchaser of that Rice, Whole Wheat, Wheat Flour or Bajiri (Cambu), a receipt on which there shall be set out—
 - (a) the date of sale;
 - (b) the quantity of rice, Whole Wheat, Wheat Flour or Bajiri (Cambu) sold,
 - (c) the price paid for the quantity of Rice, Whole Wheat, Wheat Flour or Bajiri (Cambu) sold.

**GURRYSTUFFS, PULSES, COFFEE,
PEARL BARLEY, AND CANE JAGGERY.**

THE CONTROL OF PRICES ORDINANCE, NO. 39 OF 1939.

Order.

BY virtue of the powers vested in the Controller of Prices (Food) by section 3 of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Reginald Sydney Vernon Poulter, Controller of Prices (Food), do by this Order—

(i.) revoke with effect from this date—

- (a) Food Price Order No. C-58, published in *Government Gazette* No. 9,391 of April 6, 1945;
- (b) Food Price Order No. C-72, published in *Government Gazette* No. 9,468 of October 5, 1945;
- (c) Food Price Order No. C-74, published in *Government Gazette* No. 9,474 of October 19, 1945;
- (d) Food Price Order No. C-75, published in *Government Gazette* No. 9,477 of October 26, 1945;
- (e) Food Price Order No. C-78, published in *Government Gazette* No. 9,502 of January 11, 1946;
- (f) Food Price Order No. C-80, published in *Government Gazette* No. 9,506 of January 22, 1946;
- (g) Food Price Order No. J-1 of 1944, published in *Government Gazette* No. 9,238 of February 18, 1944;
- (h) Food Price Order No. J-7 of 1944, published in *Government Gazette* No. 9,272 of May 19, 1944; and
- (i) Food Price Order dated December 12, 1943, issued by the Deputy Controller of Prices (Food), Jaffna District in respect of Currystuffs and Pulses, and published in *Government Gazette* No. 9,219 of December 24, 1943;

(ii.) fix the prices specified in columns 2, 3, 4 and 5 of the First Schedule hereto to be respectively the importer's maximum price, the maximum wholesale price per cwt. gross, the maximum wholesale price per lb. net, and the maximum retail price per lb. net, above which the articles specified in the corresponding entries in column 1 of the First Schedule hereto shall not be sold within the Municipal limits of the town of Colombo;

(iii.) fix the prices which are for the time being fixed by me as the maximum wholesale price per cwt. gross, the maximum wholesale price per lb. net, and the maximum retail price per lb. net, for the Colombo Municipality, increased by the amounts specified in columns 2, 3 and 4 of the Second Schedule hereto, to be respectively the maximum wholesale price per cwt. gross, the maximum wholesale price per lb. net, and the maximum retail price per lb. net, above which the articles specified in column 1 of the First Schedule hereto shall not be sold within the areas specified in the corresponding entries in column 1 of the Second Schedule hereto;

(iv.) direct that for the purposes of this Order—

- (a) any sale of any quantity of any article for the purpose of resale or any sale of any article in quantity of 1 cwt. gross or more at a time shall be deemed to be a sale by wholesale;
- (b) any sale of any quantity less than 1 cwt. gross of any article for the purpose of consumption or use shall be deemed to be a sale by retail;
- (c) an "importer" of any article shall mean any person who has cleared from the Customs in his name either that article or an article of the same description as that article;
- (d) a "wholesale dealer" in any article shall mean any person who is in the habit of selling by wholesale articles of the same description as that article;
- (e) the "importer's maximum price" fixed for sales within the Municipal limits of the town of Colombo shall apply to the sale by wholesale of any article by an importer to a wholesale dealer;
- (f) the "maximum wholesale price per cwt. gross" fixed for sales within the Municipal limits of the town of Colombo shall apply to all sales by wholesale in whole bags, except sales by an importer to a wholesale dealer;
- (g) the "maximum wholesale price per lb. net" fixed for sales within the Municipal limits of the town of Colombo shall apply to all sales by wholesale in quantities less than a whole bag, except sales by an importer to a wholesale dealer;

(h) the "maximum wholesale price per cwt. gross" fixed for sales outside the Municipal limits of the town of Colombo shall apply to all sales by wholesale in whole bags;

(i) the "maximum wholesale price per lb. nett" fixed for sales outside the Municipal limits of the town of Colombo shall apply to all sales by wholesale in quantities less than a whole bag;

(j) the "maximum retail price" shall apply to all sales by retail;

(k) a "whole bag" shall mean a bag or bundle filled with any commodity or article,

(l) "Town area" shall mean, at places where Sanitary Boards formerly existed, the former Sanitary Board area;

(v.) direct that in every area where maximum prices are fixed by this Order no person shall sell any article specified in column 1 of the First Schedule hereto which is adulterated with any other article or with an article of an inferior description or grade or quality;

(vi.) direct that in every area where maximum prices are fixed by this Order every trader, who has in his possession or under his control at any place or in any vehicle any article specified in column 1 of the First Schedule hereto, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the description of that article and the maximum prices fixed by this Order for that article in that area;

(vii.) direct that in every area where maximum prices are fixed by this Order every trader, who at any premises has been in the habit of selling any article specified in column 1 of the First Schedule hereto and has for the time being no stocks of that article for sale, shall exhibit in a conspicuous position at those premises for a period of three months from the date he last sold that article a notice to the effect that he has no stocks of that article available for sale for the time being;

(viii.) direct that in every area where maximum prices are fixed by this Order every person who sells by wholesale any article specified in column 1 of the First Schedule hereto shall, and every person who sells by retail any article specified in column 1 of the First Schedule shall on demand, give the purchaser of that article a receipt in which there shall be set out—

- (a) the date of sale;
- (b) the description of the article sold;
- (c) the weight of the quantity sold;
- (d) the price paid for the quantity sold; and
- (e) the nature of the transaction, that is to say whether the sale was by wholesale or by retail.

MUSTARD.

THE CONTROL OF PRICES ORDINANCE, No. 39 of 1939.

Order.

BY virtue of the powers vested in me by section 3 (read with section 2 (3)) of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Alfred Silva Kohoban Wickrome, Deputy Controller of Prices (Food), Kandy District, and Assistant Controller of Prices (Food), Uda Hewaheta division, Nuwara Eliya District, do, by this Order—

- revoke, with effect from this date, my Food Price Order No. KD-7, dated January 28, 1946, fixing maximum prices for Mustard for the Kandy District and Uda Hewaheta division in the Nuwara Eliya District;

- (2) fix the prices specified in columns 2 and 3 of the First Schedule hereto to be, respectively, the maximum wholesale prices per cwt. gross and the maximum wholesale price per lb., above which mustard shall not be sold within the areas specified in the corresponding entries in column 1 of the First Schedule hereto ;
- (3) fix the prices specified in column 2 of the Second Schedule hereto, to be the maximum retail prices per lb. net., above which mustard shall not be sold within the areas specified in the corresponding entries in column 1 of the Second Schedule hereto ;
- (4) direct that, for the purposes of this Order—
- (a) any sale of any quantity of any article for the purpose of resale, or any sale of any article in a quantity of one hundred-weight gross or more at a time, shall be deemed to be a sale by wholesale ;
- (b) any sale of any quantity of any article less than one hundred-weight gross for the purpose of consumption or use, shall be deemed to be a sale by retail ;
- (c) a "wholesale dealer" in any article shall mean any person who is in the habit of selling by wholesale articles of the same description as that article ;
- (d) the "maximum wholesale price per hundred-weight gross" shall apply to all sales by wholesale in whole bags ;
- (e) the "maximum retail price" shall apply to all sales by retail ;
- (f) a "whole bag" shall mean a bag filled with any commodity or article ;
- (5) direct that, in every area where maximum prices are fixed by this Order, no person shall sell mustard which is adulterated with any other article or with an article of an inferior description or grade or quality ;
- (6) direct that, in every area where maximum prices are fixed by this Order, every trader who has mustard in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the description of mustard and the maximum prices fixed by this Order for mustard in that area ;
- (7) direct that, in every area where maximum prices are fixed by this Order, every trader who at any premises has been in the habit of selling mustard and has for the time being no stocks of mustard for sale, shall exhibit in a conspicuous position at those premises for a period of three months from the date he last sold mustard a notice to the effect that he has no stocks of mustard available for sale for the time being ;
- (8) direct that, in every area where maximum prices are fixed by this Order, every person who sells mustard by wholesale shall, and every person who sells mustard by retail shall, on demand, give the purchaser of that article a receipt in which there shall be set out—
- (i.) the date of sale ;
- (ii.) the description of the article sold ;
- (iii.) the weight of the quantity sold ;
- (iv.) the price paid for the quantity sold ;
- (v.) the nature of the transaction, that is to say whether the sale was by wholesale or by retail
