CONCENTRATED ESSENCES.

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939. Order.

BY virtue of the powers vested in me by section 3, read with section 2 (3), of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Allan Basil Samuel Nesarajah Pullenayegum, Assistant Controller of Prices (Food) for the Island, do by this Order—

(i) revoke with effect from this date Food Price Order No. C-67 published in Government Gazette No. 9,461 of September 21, 1945;

(ii) fix the price specified in column 2 of the Schedule hereto to be the maximum price above which the concentrated essence of the description mentioned in the corresponding entry in column 1 of that Schedule shall not be sold in any part of Ceylon;

(iii) direct that in every area where maximum prices are fixed by this Order every trader, who at any premises has in his possession or under his control concentrated essence of any description mentioned in column 1 of the Schedule hereto, shall exhibit in a conspicuous position at those premises a notice in which there shall be set out the maximum price fixed by this Order for concentrated essence of that description;

- (iv) direct that every trader who sells concentrated essence of any description mentioned in the Schedule hereto shall give the purchaser thereof a receipt on which shall be set out-
 - (a) the description of the concentrated essence sold;
 - (b) quantity of the concentrated essence sold;
 - (c) the price paid therefor; and (d) the date of sale.
