A PROCLAMATION.

THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE.

Notification.

BY virtue of the powers vested in me by regulation 1 of the regulations under sections 2 and 3 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), published in the *Supplement to Gazette* No. 7,481 of August 28, 1925, I, Henry Monok-Mason Moore, Governor of Ceylon, do by this Notification confirm the declaration of the "diseased localities" specified in the Schedule hereto, made by the Government Agent, Province of Uva, the proper authority in that behalf, on April 10, 1946.

- I. The area in Medagama wasama bounded as follows :—
North by Goradiyawake kandure and Tibbutu kandure ;
East by Kandana wasama and Beddegama ;
West by Uduwera and Dickwella wasama ; and
South by Gawarawela wasama.
- II. The area in Imbulgoda wasama bounded as follows :—
North by Hingurugamuwa village ;
East by Wediguna village ;
West by Kuda Oya, and Alubogolla village ; and
South by Kottegoda Pallegama.
- III. The area in Mailagastenne bounded as follows :—
North by Badulla Oya ;
East by Kuda Oya and Kanupelella village ;
West by Badulla Oya and Welikemulla ; and
South by Elabagaha kandure.
