### GOVERNMENT NOTIFICATIONS.

THE CEYLON (STATE COUNCIL ELECTIONS) ORDER IN COUNCIL, 1931.

Revision of Registers of Voters, 1946.

IN pursuance of Article 13 of the Ceylon (State Council Elections) Order in Council, 1931, as amended by the Ceylon (State Council Elections) Amendment Order in Council, 1935, and by the Ceylon (Electors) Residence) (State Council, 1935, and by the Ceylon (Electoral Registers) (Special Provisions) Order in Council, 1946, it is hereby notified by His Excellency the Governor that every person who, being qualified to be registered in accordance with Article 8 or Article 9 of the said Order and not being already registered in any register of voters, is desirous of having his name inserted in any such register, or who, being registered in respect of a qualification which has ceased to have effect, is desirous of having his name entered on the register in respect of some other qualification, should forward his application to the registering officer of the electoral district in which the applicant resides so as to reach that officer on or before June 30, 1946.

The officers mentioned in the second column of the Schedule hereto are the respective registering officers for the electoral districts mentioned in the first column of that Schedule.
