THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE.

Notification.

BY virtue of the powers vested in me by regulation 1 of the regulations under sections 2 and 3 of the Quarantine and the regulations under sections 2 and 3 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), published in the Supplement to Gazette No. 7,481 of August 28, 1925, I, Henry Monck-Mason Moore, Governor of Ceylon, do by this Notification confirm the declaration of the "diseased localities" specified in the Schedule hereto, made by the Assistant Government Agent, Kalutara, the proper authority in that behalf, on June 14, 1946.

Schedule.

I. The area bounded as follows:-North by Ettibalanawa Vel Yaya; East by the land called Mulkadakanda; South by Kimbulawila Vel Yaya; West by Kongahawela Vel Yaya.

II. The area in the Home Division of Neuchatel Estate at Uduwara and Anguruwatota and bounded as follows:-

North by Madurawela village boundary; North by Maduraweia vinage boundary;
East by the lands at Anguruwatota belonging to villagers;
South by Indilanda-Anguruwatota P. W. D. road;
West by the lands at Uduwara belonging to villagers, and
by the Kottal Ganga.
