THE HOUSING AND TOWN IMPROVEMENT ORDINANCE.

THE following resolution passed by the State Council at a meeting held on August 6, 1946, is published for general

This Council resolves under the provisions of section 3 (b) of the Housing and Town Improvement Ordinance (Chapter 199), that on and after the first day of October, 1946, the aforesaid Ordinance shall be in force within the area defined in the Schedule hereto.

Schedule.

All that area of land situated in Norwood in Ambagamuwa korale of Uda Bulatgama Division in the Kandy District of the Central Province and bounded as follows

Every employer shall allow each Sunday as the weekly holiday to all field workers, and each Monday as the weekly holiday to all factory workers, employed under him: Provided however, that an employer may employ any field worker on a Sunday, or a factory worker on a Monday subject to the conditions

- (1) that a day within the six days next succeeding such Sunday or Monday, as the case may be, shall be allowed to that worker as a holiday;
- (2) that in respect of work done on such Sunday or Monday, as the case may be-
 - (a) a workers who has worked for 9 hours (inclusive of one hour for a meal) or for any period that falls short of nine hours by reason of the failure of the employer to provide him with work shall be remunerated at 1½ times the minimum rate of wages for a normal working day

(b) a worker who has worked for less than 9 hours (inclusive of one hour for a meal) by reason of his unwillingness to work, shall for each hour that he has worked, be paid 11 times the hourly rate (ascertained by dividing the minimum rate of wages for a normal working day by 8),

- (c) a worker who has worked for more than 9 hours (inclusive of one hour for a meal) shall be remunerated at twice the hourly rate (ascertained by dividing the minimum rate of wages for a normal working day by 8) for each hour of work in excess of 9 hours; and
- (3) that the remuneration due to a worker for work done on the weekly holiday during any period shall be paid within the time prescribed for the payment of wages for such period by section 2 (b) of the Wages Boards Ordinance.

The preceding provisions of this paragraph shall not apply to workers engaged in plucking.

Annual holidays (section 25.)

1. (a) If a male worker of not less than 16 years of age has been in continuous employment under the same employer and has worked for more than 228 days in any year (heroin after called the "qualifying year"), he shall be allowed in the next succeeding year a holiday or holidays calculated at the rate of 1 holiday for each unit of 5 days by which the number of days on which the worker has worked exceeds 228: Provided, however, that it shall not be obligatory on any employer to allow any such holiday in respect of any period of work in excess of 288 days.

(b) If a female worker or a child worker has been in continuous employment under the same employer and has worked for more than 204 days in any year (hereinafter called the "qualifying year"), such worker shall be allowed in the next succeeding year a holiday or holidays calculated at the rate of 1 holiday for each unit of 5 days by which the number of days on which the worker has worked exceeds 204: Provided, however, that it shall not be obligatory on an employer to allow any such holiday in respect of any period of work in excess

of 264 days.

2. (i) If a worker is entitled in any year to seven holidays he shall be allowed, and he shall take, those seven holidays on consecutive days.

(ii) If a worker is entitled in any year to more than seven holidays he shall be allowed, and he shall take, at least seven of those holidays on consecutive days.

3. Subject to the provisions of paragraph 2, a worker shall be allowed his holiday or holidays on a day or days to be mutually agreed upon between him and his employer.

4. (1) The remuneration payable in respect of each holiday which a worker is entitled to under paragraph 1

- 4. (I) The remuneration payable in respect of each holiday which a worker is entitled to under paragraph 1 (including a holiday which such worker is entitled to under that paragraph read with paragraph 6 (a)), by reason of work performed during the preceding year, shall be his average daily wages ascertained by dividing his total wages (exclusive of overtime and bonuses) earned by him during that year by the number of days on which the worker has worked during that year.
- (2) The remuneration payable in respect of each holiday which a worker is entitled to under paragraph 6 (b), by reason of work performed during the current year, shall be his average daily wages ascertained by dividing his total wages (exclusive of overtime and bonuses) earned by him during the current year by the number of days on which the worker has worked during that year.

(5) The remuneration due to a worker in respect of his holiday or holidays shall be paid to him before such holiday or holidays, but not earlier than 10 days before such holiday or holidays.

- 6. Where a worker intends to leave his employment of his own accord or is to be discontinued or dismissed from employment, such worker shall be entitled to take and shall take, during the period immediately preceding such leaving, discontinuance or dismissal—
 - (a) every holiday that he was entitled to in respect of the previous year which he has not already taken; and
 - (b) in ease the worker has during the current year, complied with the provisions relating to employment and work set out in paragraph I, every holiday that he would have otherwise been entitled to in the next succeeding year;

and he shall be remunerated for such holidays in accordance with the provisions of paragraph 4:

Provided, however, that the total number of holidays that such a worker might take in any year shall not exceed twenty-one.

7. For the purposes of the foregoing provisions-

"child worker" means a male worker under 16 years of age or a female worker under 15 years of age; "days on which the worker has worked" shall be deemed to include—

(i.) every holiday allowed by the employer to the worker under section 25;

- (ii.) every holiday or day of absence from work to which a worker is entitled by or under the provisions of any written law other than the Wages Boards Ordinance;
- (iii.) every day of absence on any grounds approved by the employer other than absence from the Island except on a holiday allowed by the employer under section 25;
- (iv.) every day of absence due to any injury to the worker caused by an accident arising out of and in the course of his employment, provided such injury had been notified to the employer;
- (v.) every day of absence due to any occupational disease specified in Schedule III. of the Workmen's Compensation Ordinance (Chapter 117);

- (vi.) every day on which the employer fails to provide work for the worker; and
- (vii) every day of absence due to a strike or lockout that is not illegal, in case such days do not in the aggregate exceed 30 days a year

but shall not include the day fixed as the weekly holiday under section 24,

" year" moans a continuous period of 12 months.

5. The remuneration due to a worker in respect of his holiday or holidays shall be paid to him before such holiday or holidays, but not earlier than 10 days before such holiday or

holidays.
6. Where a worker intends to leave his employment of his own accord or is to be discontinued or dismissed from employment, such worker shall be entitled to take and shall take. during the period immediately preceding such leaving, discontinuance or dis missal-

(a) every holidar that he was entitled to in respect of the previous year which he has not already taken; and (b) in case the worker has during the current year, complied with the provisions relating to employment and work set out in paragraph 1, every holiday that he would have otherwise been entitled to in the next succeeding

and he shall be remunerated for such holidays in accordance with the provisions of paragraph !:

Provided, however, that the total number of holidays that such a worker might take in any year shall not exceed twentyone.

For the purposes of the foregoing provisions-

"child worker" means a male worker under 16 years of age or a female worker under 15 years of age

"days on which the worker has worked" shall be deemed to include-

> (1.) every holiday allowed by the employer to the worker under section 25

(11.) every holiday or day of absence from work to which a worker is entitled by or under the provisions of any written law other than the Wages Boards Ordinance;

(iii.) every day of absence on any grounds approved by the employer other than absence from the Island except on a holiday allowed by the

employer under section 25; (iv.) every day of absence due to any injury to the worker caused by an accident arising out of and in the course of his employment, provided such injury had been notified to the employer;

(v.) every day of absence due to any occupational disease specified in Schedule III. of the Workmen's Compensation Ordinance (Chapter 117):

(vi.) every day on which the employer fails to provide work for the worker; and

(vii.) every day of absence due to a strike or lockout that is not illegal, in case such days do not in the aggregate exceed 30 days a year:

but shall not include the day fixed as the weekly holiday under section 24.

"year" means a continuous period of 12 months.

The foregoing decisions shall not apply in respect of employment at any time more than 12 months prior to the date on which the decisions come into force.

TRADE DISPUTE—CRAIGFOREST ESTATE, WITLIMADA.

THE All Ceylon Estate Workers' Union presented a petition to me under section 6 (1) of the Essential Services (Avoidance of Strikes and Lockouts) Order, 1942, in connection with a trade dispute arising out of the termination of the services of Tirupathy, a labourer employed on the above estate, by the Superintendent, Craigforest Estate, Wellmada. This petition was referred to the District Judge, Badulla, by me in terms of section 6 (2) of the said Order for adjudication.

2. The following award dated August 6, 1946, made by the District Judge, Badulla, is published for general information in terms of section 8 (4) of the said Order:—

"It is ordered that the dismissal from employment of the labourer Tirupathy about April 1, 1946, by the respondent was justified.

And it is further ordered that the application of the petitioner be and the same is hereby dismissed.

The Director of Civil Aviation or the Ceylon Government will not be liable for any damage to the linen, plate, crockery, glass, cutlery, cooking utensils, &c., which are the property of the contractor unless such damage has, in the opinion of the Director of Civil Aviation, whose decision on the matter shall be final, been caused by the wilful negligence of the lessor or the servants employed under him.

- 8. The Director of Civil Aviation reserves the right to decide what the service of the refreshment buffet shall be and to vary same from time to time as circumstances may require.
- 9. The Contractor must provide adequate and efficient management and supervision in connection with the due performance of the contract, and applicant must give details of the same when offering.
- $10.\,\,$ The interior of the Refreshment Buffet must be kept clean by the servants of the contractor.

"Improvement in Refrigeration".

Abstract.—The inventor describes and claims a refrigerating system of employing a water solution of solid absorbent, e.g., lithium chloride and working under partial pressure. The elements of the system are :—(a) a generator comprising two chambers connected by a plurality of vertical riser tubes; the solution fills the bottom chamber and a portion of the riser tubes. When heat is applied by means of steam to the riser tubes, vapour is expelled from the solution and rises up each tube carrying with it by vapour life action an annulus of concentrated solution, (b) condenser, in which the expelled vapour is condensed by the use of circulating water, (c) evaporator, in which the condensed water is evaporated; this is the colling element of the system, (d) absorber, in which the evaporated vapour is absorbed into concentrated solution giving out heat in the process. Like the condenser, this too is cooled by circulating water, (e) heat exchanger, in which heat is transferred from the concentrated solution to the dilute solution.

Concentrated solution which has been raised by vapour lift flows through the heat exchanger to the absorber where it gets diluted by absorbing water vapour. The dilute solution flows through another passage in the heat exchanger to the evaporator whore it is separated into water vapour and concentrated solution. The path of the water vapour is through the condenser and ovaporator to the absorber. The generator and condenser work at the same pressure, and the evaporator and absorber at a lower prossure, the prossure differential between the two being maintained by liquid columns.

The evaporator may be positioned in the coolling duct of an air-conditioning system. The temperature of the air to be conditioned may be made to operate sequentially switches which control the flow of oil to the oil-burners which heat the steam holler

8.
