- (m) if any instalment of rent or any part thereof shall not be paid on the first day of each month, whether the same shall be lawfully demanded or not, such instalment of rent shall carry interest at the rate of nine per centum per annum till payment in full ;
- (n) the lessee shall not remove or disturb any Government trigonometrical station or beacon or boundary pillar or marks.

6. The Government Agent reserves the right to reject any or all the tenders.
