FINAL ORDERS.

LAND SETTLEMENT ORDINANCE.

Settlement Order No. 831 (Kurunegala).

WHEREAS a settlement notice under section 4 of the Land Settlement Ordinance was duly published in the *Gazette* No. 8,050 of May 18, 1934, and as otherwise required by the said section, in respect of the lands situated in the village of Mirissala, in the Madure korale of the Weudawih hatpattu of the Kurunegala District in the North-Western Province, and described as lots 1, 2, 3, 5, 9, 15, 17, 19, 21, 22, 23, 24, 27, 28, 29, 31, 32, 35, 35½, 39, 46½, 48, 49, 52, 53, 56, 58, 59, 60, 61, 62, 63, 64, 67, 68, 69, 73, 74, 76 and 80 in block survey preliminary plan No. 829 (*vide* Settlement Notice No. 757).

LAND SETTLEMENT ORDINANCE.

Settlement Order No. 832 (Kurunegala).
