PRICE ORDERS.

THE CONTROL OF PRICES ORDINANCE, NO. 39 OF 1939.

KEROSENE OIL.

Order.

BY virtue of the powers vested in the Assistant Controller of Prices by section 3 of the Control of Prices Ordinance, No. 39 of 1939, as amended by paragraph (2) of the Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, James Albert Arijunan Bartlett, Assistant Controller of Prices (Miscellaneous Articles), Kalutara District, do by this Order—

- (1) revoke the Order dated December 1, 1945, published in *Government Gazette* No. 9,493 of December 14, 1945, in so far as it relates to the maximum prices of kerosene oil fixed therein for the Kalutara District;
- (2) fix the prices in columns 2, 3, 4 and 5 of the Schedule hereto to be respectively the agent's maximum price per gallon to a wholesale dealer, the agent's maximum price per gallon to an authorised distributor, the wholesale dealer's maximum price per gallon to an authorised distributor, and the maximum retail price per bottle, above which kerosene oil of any brand shall not be sold within the corresponding areas specified in column 1;
- (3) direct that the maximum price which may be demanded by any person for any quantity of kerosene oil which is more or less than one gallon or one bottle, as the case may be, shall be determined by reference to the appropriate maximum price per gallon or per bottle fixed by this Order;
- (4) direct that any person who exposes for sale any kerosene oil of any brand at any premises within the corresponding areas specified in column 1 shall exhibit in a conspicuous place at those premises a notice on which there shall be set out the maximum prices fixed by this Order in respect of that brand of kerosene oil;
- (5) direct that no person shall sell any kerosene oil of any brand which is adulterated with any other article or with any oil of an inferior description or quality;
- (6) direct that any person who sells any kerosene oil of any brand shall, on demand, give the purchaser of that kerosene oil a receipt on which there shall be set out—
 - (a) the brand of kerosene oil sold;
 - (b) the quantity of kerosene oil sold;
 - (c) the price paid for the quantity of kerosene oil sold;
 - (d) the date of sale.
- (7) direct that for the purpose of this Order a bottle shall be deemed to be one-sixth part of an imperial gallon.

BY virtue of the powers vested in the Deputy Controller of Prices (Food) by section 3 (read with section 2 (3)) of the Control of Prices Ordinance, No. 39 of 1939, as amended by Regulations, I, Kathiravaloo Kanagasundram, Deputy Controller of Prices (Food), Kegalle District, do by this Order—

- (1) revoke with effect from this date my Orders dated—

- (i) revoke with effect from this date my Food Price Order No. C—91 published in *Government Gazette* No. 9,531 of March 15, 1946;

KEROSENE OIL.

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Order.

BY virtue of the powers vested in me by section 3, read with section 2 (3), of the Control of Prices Ordinance, No. 39 of 1939, I, Don Cornelis Perera Benéragama, Assistant Controller of Prices (Miscellaneous Articles), Kurunegala District, do, by this Order—

- (1) revoke with effect from this date Order dated November 29, 1945, published in *Government Gazette* No. 9,493 of December 14, 1945, relating to the maximum prices per four-gallon tin, the maximum price per gallon (in bulk) and the maximum price per bottle of Kerosene oil of the brand specified therein;
- (2) fix the prices specified in column 2, 3, and 4 of the schedule hereto to be respectively, the maximum price per four-gallon tin, the maximum price per gallon and the maximum price per bottle above which Kerosene oil of the brand named and specified at the head of each column shall not be sold (by wholesale or retail) within the areas specified in the corresponding entry in column 1 of the schedule hereto;
- (3) direct that when four-gallons or any multiple of four gallons of Kerosene oil of any description specified in column 1 of the schedule hereto are sold in four-gallon tins the maximum price to be charged for the same shall be determined by reference to the appropriate maximum price specified in column 2 of the schedule hereto;
- (4) direct that every trader who sells any Kerosene oil of the brand specified in the schedule hereto at any premises within the limits of any areas mentioned in column 1 of the schedule hereto shall exhibit in a conspicuous position at those premises a notice on which shall be set out the maximum price fixed by this Order in respect of that brand of Kerosene oil;
- (5) direct that no such trader shall sell any Kerosene oil of any brand specified in the schedule hereto which is adulterated with any other article or with any oil of an inferior description of the quality;
- (6) direct that every trader, who sells Kerosene oil of any brand specified in the schedule hereto, shall give to the purchaser of the Kerosene oil, on demand, a receipt on which shall be set out—
 - (a) the brand of the Kerosene oil sold;
 - (b) the quality of Kerosene oil sold;
 - (c) the price paid; and
 - (d) the date of sale;
- (7) direct that for the purpose of this Order a "bottle" shall be deemed to be one-sixth ($\frac{1}{6}$ th) of an Imperial gallon;

(8) direct that sale of any quantity below one bottle restricted to half-bottle and quarter-bottle and sale of any intermediate quantity prohibited;

(9) direct that the price shall be calculated at the rate in the case of sale by half or;

Order.

BY virtue of the powers vested in the Deputy Controller of Prices (Food) by section 3 read with section 2 (3) of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Alfred Silva Kohoban Wickreme, Deputy Controller of Prices (Food), do by this Order—

- (i.) revoke with effect from this date my Order dated September 4, 1944, published in *Government Gazette* No. 9,309 of September 8, 1944, fixing the maximum wholesale price per bag of 80 measures rice;
- (ii.) fix the prices specified in column 2 of the Schedule hereto to be respectively the maximum wholesale price per bag above which rice of the description and grade shall not be sold in the areas mentioned in the corresponding entry in column 1 of the Schedule hereto;
- (iii.) direct that provisions of paragraphs (iii.) to (vi.) of the Order by the Deputy Controller of Prices (Food), Vavuniya District, dated June 22, 1943, and published in *Government Gazette* No. 9,142 of July 2, 1943, fixing the maximum price of rice, shall apply in this case as though these paragraphs were herein incorporated.
