KNOW Ye that by virtue of the powers vested in the Governor by section 5 (1) of the Cemeteries and Burial Ordinance (Chapter 181) I, John Curtois Howard, Officer Administering the Government, do by this Proclamation establish from the date hereof a general cemetery on the land described in Schedule A hereto for the burial or cremation of the dead within the limits specified and defined in Schedule B hereto.

And I do further, under section 5 (3), wholly exempt the general cemetery so established from the operation of sections 10, 15, 16 and 23 of the Ordinance.
