# A PROCLAMATION.

KNOW Ye that, by virtue of the powers vested in the Governor by section 4 of the Small Towns Sanitary Ordinance (Chapter 197), I, John Curtois Howard, Officer Administering the Government of Ceylon, do by this Proclamation exclude from the operation of the said Ordinance with effect from the first day of January, 1947, the town of Kahawatta which is partly within the Divisional Revenue Officer's Division of Atakalan Korale, and partly within the Division of Atakalan Korale, and partly within the Divisional Revenue Officer's Division of Nawadum Korale, in the Ratnapura District, and which was brought under the operation of the said Ordinance by means of a resolution duly passed at a public session of the Legislative Council on March 17, 1915, and published in *Gazette* No. 6,705 of March 19, 1915.

A PROCLAMATION.

KNOW Ye that, by virtue of the powers vested in the Governor by sections 3 and 6 of the Village Communities Ordinance (Chapter 198), I, John Curtois Howard, Officer Administering the Government of Ceylon, do by  $\mathbf{this}$ Proclamation-

- (1) declare that, with effect from the first day of January, 1947, the area now known as the town of Kahawatta, which is partly within the Divisional Revenue Officer's Division of Atakalan Korale, and partly within the Divisional Revenue Officer's Division of Neural Web are the Detraction of the Statement of Nawadum Korale, in the Ratnapura District, and which comprises the areas described in Schedule A and Schedule B hereto, shall be brought within the operation of the said Ordinance; and
- (2) alter and redefine, with effect from the aforesaid date-
  - (a) the limits of the Pannil Pattu village area in the Divisional Revenue Officer's Division of Atakalan Korale by the addition to that village area of such part of the area now known as the town of Kahawatta as is described in Schedule A hereto; and

    (b) the limits of the Uda pattu village area in the Divisional Revenue Officer's Division of Nawadum Korale by the addition to that village area of such part of the area now known as the town of Kahawatta as is described in Schedule B hereto.

# Schedule A.

All that area of land forming part of the Sanitary Board Town of Kahawatta situated in Nugawela village in Pannil pattuwa of Atakalan Korale of Ratnapura District in the Sabaragamuwa Province and bounded as follows :—

- North by a line drawn from the centre of the confluence of Wey Ganga and Panawenna Ela eastwards along the centre of Wey Ganga as far as a point east of the north-castern corner of lot Y3 in Final Village Plan 4.
- East by a line drawn from the last-mentioned point southwards along the centre of Wey Ganga and Atakalan Ela as far as a point in line with the northern boundary of lot 14 in Final Village Plan 4.
- South by a line drawn from the last-mentioned point southwestwards along the centre of Atakalan Ela as far as a point in line with the northern boundary of Walaa point in the with the northern boundary of Wala-potukumbura in lot J3 in Final Village Plan 4, thence by a line drawn westwards across the said Ela and along the northern boundary of the said Walapotukumbura and crossing the Pelmadulla-Rakwana P. W. D. road at the 724 mile post and through lot K3 in Final Village Plan 4 to the right bank of Volawella bank of Yodawella.
- West by a line drawn from the last-mentioned point northwards along the right bank of Yodawella which runs through lots K3 and J3 and along the castern boundaries of lots J3 and B3 in Final Village Plan 4 to the north-eastern corner of the said lot B3, thence by a line drawn northwards through lot W3 in Final Village Plan 4 and through Wey Ganga to the starting point of the northern limit of the area.

# Schedule B.

All that area of land forming part of the Sanitary Board Town of Kahawatta situated in Kahawatta village in Uda pattuwa of Nawadun Korale in Ratnapura District of the Sabaragamuwa Province and bounded as follows :

- North by a line drawn from the centre of Panawenna Ela at the confluence with the Irrigation Channel (Lot 132) in Final Village Plan 183 eastwards across the Panawenna Ela to the right bank of the said Irrigation channel, thence by a line drawn south-eastwards along the right bank of the said channel till it meets the western boundary of the Pelmadulla-Rakwana road, thence by a line drawn eastwards across the (Lot 142), thence by a line drawn castwards across the (Lot 142), thence by a line drawn north-eastwards and eastwards along the right bank of the said Irrigation channel (Lot 142) till it meets a point in line with the northern boundary of Lot 145.
- East by a line drawn from the last-mentioned point southwards, eastwards and again southwards along the right bank of the Irrigation channel (Lot 142) in Final Village Plan 183 and of the Irrigation channel Final Village Pian 183 and of the irrigation channel east of Lot 8 and crossing the Gansabhawa road (Lot 20) eastwards along the right bank of the Irrigation Channel, north of Lots 7, 12, 13, 14, 17 and 19 till it meets the right bank of the Irrigation channel (Lot 30), thence by a line drawn eastwards along the right bank of the Irrigation channel (Lots 30 and 33) till it meets the stream (Lot 198), thence by a line drawn southwards along the right thence by a line drawn southwards along the right bank of the said stream till it meets the centre of the Wey Ganga.

VILLAGE COMMUNITIES ORDINANCE.

by Proclamations the area now known as the Watta which is partly within the Divisional m's Division of Atakalan Korale, and partly visional Rovenue Officer's Division of Nawadun ale, in the Ratnapura District, has, with offect from the t day of January, 1947, been excluded from the operation of the Small Towns Sanitary Ordinance (Chapter 197), and brought within the operation of the Village Communities Ordinance (Chapter 198), and added partly to the Pannil Pattu village area in the Divisonal Rovenue Officer's Division of Atakalan Korale and partly to the Uda Pattu village area in the Divisional Rovenue Officer's Division of Nawadum Korale :

Now, therefore, by virtue of the powers vested in the Governor by section 41 of the Village Communities Ordinance (Chapter 198), T. John Curtois Howard, Officer Administering the Government of Coylon, do by this Order, with effect from the first day of January, 1947---

- (a) transfor (i.) to the Village Committee of the aforesaid Pannil Pattu village area such of the properties and such portion of the funds acquired or received by or vested in the Sanitary Board of the Ratnapura District for the use and the benefit of the town of Kahawatta as are specified in Schedule A hereto, and
- (ii.) to the Village Committee of the aforesaid Uda Pattu village area such of the properties and such portion of the funds acquired or received by or vested in the Sanitary Board of the Ratnapura District for the use and benefit of the town of Kahawatta as are specified in Schedu.e B hereto;

(b) declare that-

- (i.) such portion of the aforesaid funds as is referred to in paragraph (a) (i) of this Ordor and the revenue derived from such part of the town of Kahawatta as has been added to the aforesaid Pannil Pattu village area shall be employed by the Village Committee of that village area for the use and benefit of that part, and
- (ii.) such portion of the aforesaid funds as is referred to in paragraph (a) (ii) of this Order and the rovenue dorived from such part of the town of Kahawatta as has been added to the aforesaid Uda Pattu village area shall be employed by the Village Committee of that village area for the use and benefit of that part ;
- (c) apportion and assign to the Village Committee of the aforesaid Pannil Pattu village area three-fourths of the rights, liabilities, debts or obligations of the aforesaid Santary Board under any contract entered into by that Board for the benefit of the town of Kahawatta, and to the Village Committee of the Uda Pattu village area one-fourth of such rights, liabilities, debts or obligations;
  (d) prescribe the terms and conditions set out in Schedule
- (d) prescribe the terms and conditions set out in Schedule C hereto as the terms and conditions on which the servants specified in that Schedule and employed by the aforesaid Sanitary Board for the purposes relating to the town of Kahawatta may be transferred to the service of the Village Committee of the aforesaid Pannil Pattu village area; and
- (e) direct the Government Agent of the Sabaragamuwa Province---

.

(i.) to collect all moneys due to the aforesaid Sanitary Board (whether as rates, taxes, licence duties or otherwise), from the inhabitants of the area now known as the town of Kahawatta;

- (ii.) to recover such moneys in the manner in which they would have been recovered if that town had not been excluded from the operation of the Small Towns Sanitary Ordinance; and
- (iii) to pay three-fourths of such moneys when so collected and recovered to the Village Committee of the aforesaid Pannil Pattu village area and one-fourth of such moneys to the Village Committee of the aforesaid Uda Pattu village area.

4, Nugawela. 5. An undivided half share of the general cemetery situated on the Iand called Mahayayahena—lot 1 B in F. V. P. 12 Wellandura, in extent 1 acre, which is being used by the inhabitants of the Wellandura built-up area and Kahawatta town.

6. The part of the pipe borne water supply which extends from the Kahawatta Government Hospital to Kahawatta town.

7. Four street lamps, 23 rat cages, 4 mammoties (2 large and 2 small), 8 brooms, 2 pickaxes, 9 cane baskets, 5 handles for brooms, 22 latrine buckets, 3 stock buckets. 1 disinfecting drum, 2 rakes, 2 galvanized buckets, 2 locks, (damaged), 1 wooden wheeled scavanging cart, 1 wooden wheeled conservancy cart, 1 fire extinguisher, 2 manilla ropes, 3 axes with handles, 3 axes with chisel and point. 3 handles for pickaxes and 2 galvanized buckets.

8. Three-fourths of such cash balances as may be vested in the Sanitary Board of the Ratnapura District on December 31, 1946, for the use and benefit of the town of Kahawatta.

#### Schedule B.

1. The land called Mahaliyaddegodellewatte surveyed as lot 193 B in Extract 2 of B. S. P. P. 183 Kahawatta, acquired for a market.

2. The land called Kiriammawattekumbura and Kiriammawattegodella surveyed as lots 192B and 193D in Extract 3 of B.S.P.P. 183 Kabawatta acquired for a market.

3 of B. S. P. P. 183, Kahawatta, acquired for a market.
3. One-fourth of such cash balances as may be vested in the Sanitary Board of the Ratnapura District on December 31, 1946, for the use and benefit of the town of Kahawatta.

#### Schedule C.

1. The two scavenging labourers and the three conservancy labourers of the town of Kahawatta shall, when transferred to the service of the Village Committee of the Pannil Pattu village area in the Divisional Revenue Officer's Division of Atakalan Korale, be paid at the following rates :---

- Two scavenging labourers at 66 cents each per day exclusive of a temporary increase of 22 cents each per day for the duration of the present emergency.
- Three conservancy labourers at 74 cents each per day exclusive of a temporary increase of 22 cents each per day for the duration of the present emergency.

2. One water labourer (an employee of the Department of Medical and Sanitary Services attached to the Kahawatta Government Hospital) towards whose salary a sum of rupees fifteen per mensem shall be reimbursed to the Government in consideration of the services rendered by him in connection with the water supply to the Pannil Pattu village area in the Divisional Revenue Officer's Division of Atakalan Korale.
