

## THE CEYLON (STATE COUNCIL ELECTIONS) ORDER IN COUNCIL, 1931.

## Notice under Article 32.

**Election of a Member of the State Council for the Electoral District No. 27, Morawaka, in pursuance of a Notice under Article 23 (3) and (5) published in Gazette Extraordinary No. 9,628 of 13th November, 1946.**

IN pursuance of the powers vested in the Governor by Article 32 (3) of the Ceylon (State Council Elections) Order in Council, 1931, it is hereby notified by the Officer Administering the Government of Ceylon—

- (1) that the election in the Electoral District No. 27, Morawaka, is contested;
- (2) that a poll will be taken in the aforesaid Electoral District on the eighth day of February, 1947, between eight o'clock in the forenoon and five o'clock in the afternoon;

NOTICE is hereby given under section II (2) of the Ceylon (Parliamentary Elections) Order in Council, 1946, that the first Register of Electors for each of the above Electoral Districts has been completed and that such register is open for inspection at the Kandy Kachcheri, during office hours.

*Harvesting of Paddy in Raigam Korale and Panadura  
Totamune Maha 1946-47.*

BY virtue of the powers vested in me by the Defence (Miscellaneous) Regulations 37, the Defence (Purchase of Foodstuffs) Regulations, 1942, the Defence (Paddy Cultivation) Regulations, 1943, and the Defence Food Rationing (Special Provisions) Regulations, 1944, I, Pinnaduwege Arthur

- (d) The share or shares of the produce to which such person or persons may be entitled.

2. I do further direct that—

- (a) no person who has or may have hereafter possession of or control over any paddy harvested or to be harvested during the present Maha season under any title or claim whatsoever shall remove or cause to be removed or permit to be removed such paddy from the field or threshing floor to a barn or other place of storage except on a permit from the Village Headman or the Vel Vidane of the area in which the field or threshing floor is situated notwithstanding any surference permitted by proviso (a) to Regulation 4 of the Defence (Purchase of Paddy) Regulations, 1942 ;
- (b) the Government levy of two bushels of well-cleaned and dried paddy per acre should be handed over to the Village Headman or Vel Vidane at the threshing floor ;
- (c) no paddy shall be utilized for consumption by an owner or his dependant possessing a rice ration book until the surrender of the appropriate number of rice coupons to the Village Headman or Vel Vidane ;
- (d) permits for transport within the same Chief Headman's Division will be issued by the Village Headman or the Vel Vidane concerned and for transport from the Chief Headman's Division to another or to any place outside the District will be issued by me.
