Harvesting of Paddy in West Gıruwa Pattu—1946/17 Maha Season.

BY virtue of the powers vested in me by the Defence (Miscellaneous) Regulation 37, the Defence (Purchase of Foodstuffs) Regulations, 1942, and the Defence (Paddy Cultivation) Regulations, 1943, I do hereby direct that :---

- (1) No cultivator, shareholder or other person having interest in any paddy field, situated within the West Giruwa Pattu of Hambantota District, shall remove any paddy harvested in 1946/47 Maha season, from a threshing floor until the harvest has been checked and verified by the Vel Vidane of the Division.
- (2) Removal thereafter to the barn or other place of storage within the West Giruwa Pattu should only be on permits on Form I. P. S. $33_{(a)}$ issued by the Vel Vidane of the area in which the threshing floor is situated.
- (3) Removal to places outside the Pattu should only be on permits issued by me.
