KNOW Ye that by virtue of the powers vested in me by section 30 of the Births and Deaths Registration Ordinance (Chapter 94), I, Henry Monck-Mason Moore, Governor of Ceylon, do by this Proclamation-

- (a) amend the Proclamation under the said section, dated September 12, 1935, and published in the Supplement to Gazette No. 8,146 of September 20, 1935, in the manner set out in the Schedule hereto; and
- (b) declare that this Proclamation shall come into effect on the first day of July, 1947.

### Schedule.

Schedule I to the Proclamation dated September 12, 1935, and published in the Supplement to Gazette No. 8,146 of September 20, 1935, is hereby amended by the substitution, for the definition of Kalmunai Town, under the heading "Eastern Province—Batticaloa District", therein appearing and reproduced in Column I, of the definition appearing in Column II herein der hereunder.

#### Column I

Limits as defined by Proclamation dated September 12, 1935.

Kalmunai Town comprising the area within the following boundaries :-

North: By a minor road known as Thalavaddavan road from Naippaddimunai leading to the sea.

East: By the sea.

South: By Kalmunaıkudi village.

West: By paddy fields known as Karavakuvaddai and Aiyileadi road otherwise known as "Florrie Road".

#### Column II

Limits as defined by this Proclamation.

Kalmunaı Town comprising the area within the following boundaries :-

North: By a line drawn from a point on the northern boundary of Manalchenai road in prolongation of the eastern boundaries of lots 9 and 8 in P. P. A 387 north-eastwards along the northern boundary of the said road till it meets the main road to Batticaloa, thence by a line drawn north-eastwards crossing the road and along the northern boundary of Thalavaddavan road to the end of the said Thalavaddaven road, thence by a line drawn in prolongation of the said boundary of the road to the low water mark of the sea.

East: By a line drawn from the last mentioned point south-eastwards along the low water mark of the sea to a point in the said water mark in line with the southern boundary of the boundary road.

South: By a line drawn from the last mentioned point south-westwards to the southern boundary of the boundary road and along the southern boundary of the said road to the centre of the main road to Batticaloa.

West: By a line drawn from the last mentioned point north-westwards along the centre of the main road to Batticaloa till it meets the point where the northern limit of Saintamaruthu village turns westwards, thence by a line drawn westwards along the said village limit to the western edge of the Podiyarkulam bund, thence by a line drawn north-westwards along the-western edges of Podiyarkulam, Kannakulam,

Thalayadikulam and Kalladıkulam bunds to the south-eastern corner of the unallotted strip of high land lying to the south of lot 9 in P. P. 267, thence by a line drawn westwards along the southern boundary of the said strip of high land shown in P. P. 267 as far as a point in prolongation of the eastern boundary of lot 20 in P. P. 267, thence by a line drawn northwards to the south-eastern corner of the said lot 20 and along the eastern boundary of the said lot to the southern boundary of the Kittangi road, thence by a line drawn northwards in con-tinuation of the said boundary crossing the said road to the starting point of the northern limit of the area.

THE DEFENCE (FINANCE) REGULATIONS.

Order under Regulation 5 (1).

IN pursuance of the powers vested in me by regulation 5 (1) of the Defence (Finance) Regulations, which, in accordance with the Supplies and Services (Transitional Powers) Order, 1946, has effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, of the Imperial Parliament, I, Henry Monck-Mason Moore, Governor of Ceylon, do by this Order

- (1) grant exemption from that regulation in respect of-
  - (a) the taking or sending out of Ceylon of any bills of exchange or promissory notes which are payable in a currency of the sterling area and are not or have not at any time been legal tender in the sterling area;

(b) the taking or sending out of Ceylon to any part of India other than French or Portuguese India

- of any currency in any amount;
  (c) the taking out of Ceylon for personal travelling expenses by any person, other than a person described in the Schedule hereto when on official duty, of-
  - (1) currency notes expressed in a currency of the sterling area, not exceeding Rs. 270 in value, and
  - (ii) in addition to such notes, foreign currency other than currency of the sterling area, not exceeding Rs. 140 in value;
- (d) the taking or sending out of Ceylon of money orders payable in a currency of the sterling area to places in the British Empire other than Canada and Newfoundland;
- (e) the sending out of Ceylon, to any destination in the sterling area, of any postal order payable in sterling other than a postal order sent to any member of His Majesty's forces serving in Iraq;
- (f) the sending out of Ceylon, to members of His Majesty's forces serving in Iraq, of postal orders payable in sterling so long as the amount sent by any person on any one day does not exceed £.2—2—0;
- (g) the taking or sending out of Ceylon, to any part of India other than French or Portuguese India, of securities payable in a currency of of the sterling area;

and

(2) revoke the Order made under the aforesaid regulation 5 (1) and published in Gazette No. 9,490 of November \_30, 1945.

THE DEFENCE (FINANCE No. 3) REGULATIONS. Order under regulations 1 and 7.

IN pursuance of the powers vested in me by regulations 1 and 7 of the Defence (Finance No. 3) Regulations, which in accordance with the Supplies and Services (Transitional Powers) Order, 1946, have effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, of the Imperial Parliament, I, Henry Monck-Mason Moore, Governor of Ceylon, do by this Order-

(1) specify the bank notes mentioned in the First Schedule hereto as notes to which the Defence (Finance No. 3)

Regulations shall apply;

(2) grant exemption from the aforesaid regulation 1 in respect of-

- (a) the bringing into Ceylon at any one time, by any person travelling to Ceylon in any ship or aircraft (not being a person employed or engaged in any capacity on board the ship or aircraft or a person described in the Second Schedule hereto travelling on official duty) of bank notes mentioned in the aforesaid First Schedule, if but only if, the amount of such notes does not exceed twenty pounds in value;
- (b) the bringing into Ceylon by any person employed or engaged in any capacity on board a ship touching at any port, or an aircraft landing at any place in Ceylon, of bank notes mentioned in the aforesaid First Schedule if, but only if, the amount of such notes does not exceed such amount as may be specified in a certificate issued to him by the Master or Purser of such ship or the person in charge of such aircraft; and
- (c) the importation into Ceylon from any part of India other than French or Portuguese India of bank notes to which the Defence (Finance No. 3) Regulations apply;

and

(3) revoke the Order made under the aforesaid regulations 1 and 7 and published in Gazette No. 9,490 of November 30, 1945.

THE SHIPS AND AIRCRAFT (TRANSFER RESTRICTION) Act, 1939.

General sanction for the transfer or mortgage of certain ships.

The Defence (Control of Textiles) Regulations, 1945, published in Gazette Extraordinary No. 9,388 of March 28, 1945, as varied by any subsequent Order, are hereby further varied as follows:

    - (b) in the case of regulated textiles in the form of unused sarongs, camboys, veddies or sarees, any quantity in excess of two such articles;
    - (c) in the case of regulated textiles in the form of identical or similar articles of apparel being unused articles (other than sarongs, camboys, veddies or sarees), any quantity in excess of one dozen such articles;
    - (d) in the case of any other regulated textile, any quantity in excess of such quantity as may be specified for that textile by the Controller in a notice published in the Gazette:

Provided, however, that the preceding provisions of this paragraph shall not apply in any case—

- (a) where a dealer keeps at his registered store any quantity of regulated textiles for purposes of his business, or
- (b) where a person employed by a dealer transports to a registered store of the dealer any quantity of regulated textiles procured for the purposes of the business of the dealer.

In any prosecution for contravening the provisions of paragraph (1), in relation to rationed textiles, it shall be a sufficient defence for the accused to prove that the quantity of rationed textiles in respect of which the offence is alleged to have been committed had been purchased by the surrender of valid coupons (within the meaning of these regulations) or of coupon equivalent documents, such coupons and documents being coupons and documents issued to him by the Controller, and having a point value equal to the point value assigned for such quantity by these regulations.";

(2) in regulation 16, by the substitution, for paragraph (2),

of the following new paragraph:—

"(2) No dealer shall keep or permit to be kept in his registered store or stores, and no hawker shall keep in his possession, any regulated textile other than a regulated textile which has been numbered by his fact the state. purchased by him for the purposes of his business as such dealer or hawker and in respect of which he holds an invoice, a debit-note, or a cash receipt, specifying his name as the name of the purchaser.";

#### Part III.

#### Overtime Rate.

In respect of each hour of work in excess of the normal working day, the minimum overtime rate shall be the minimum hourly rate (ascertained by dividing the minimum daily rate by 8) increased by 50 per cent. of such minimum hourly rate.

#### Part IV.

## Weekly Holiday (Section 24).

Every employer shall allow each Sunday as the weekly holiday to all workers employed under him: Provided, however, that an employer may employ any worker on a Sunday, subject to the conditions—

- (1) that a day within the six days next succeeding such Sunday shall be allowed to that worker as a holiday; and (2) that in respect of work done on a Sunday-
  - (a) a worker who has worked for less than 9 hours (inclusive of one hour for a meal) by reason of his unwillumgness to work, shall, for each hour that he has worked, be paid 1½ times the hourly rate (ascertained by dividing the minimum rate of wages for a normal working day by 8),
    (b) a worker who has worked for 9 hours (inclusive of one hour for a meal) or for any period that falls short of

nine hours by reason of the failure of the employer to provide him with work, shall be remunerated at 1½ times the minimum rate of wages for a normal working day.

(c) a worker who has worked for more than 9 hours (inclusive of one hour for a meal) shall be remunerated at twice the hourly rate (ascertained by dividing the minimum rate of wages for a normal working day by 8) for each hour of work in excess of 9 hours.

## Annual Holidays (Section 24).

1. (a) If a male worker has been in continuous employment and has worked under the same employer for more than 232 days in any year (hereinafter called the "qualifying year"), he shall be allowed in the next succeeding year a holiday or holidays calculated at the rate of one holiday for each unit of 4 days by which the number of days on which the worker has

worked exceeds 232: Provided, however, that it shall not be obligatory on an employer to allow any such holiday in respect of any period of work in excess of 288 days.

(b) If a female worker has been in continuous employment and has worked under the same employer for more than 204 days in any year (hereinafter called the "qualifying year"), she shall be allowed in the next succeeding year a holiday or holidays calculated at the rate of one holiday for each unit of 4 days by the number of days on which the worker has worked exceeds 204: Provided, however, that it shall not be obligatory on an employer to allow any such holiday in respect of any period of

work in excess of 260 days.

In this paragraph "days on which a worker has worked" includes—

- (a) every holiday allowed by the employer to the worker under section 25 at any earlier time in any year under
- (a) every holiday answer by the employer to the worker under section 25 at any earner time in any year under consideration;
  (b) every holiday or day of absence from work to which a worker is entitled by or under the provisions of any written law other than the Wages Boards Ordinance;
  (c) every day of absence on any grounds approved by the employer;
  (d) every day of absence due to any injury to the worker caused by an accident arising out of and in the course of his

- employment.
- (e) every day of absence due to any occupational disease specified in Schedule III. of the Workmen's Compensation

Ordinance (Cap. 117);

(f) every day on which the employer fails to provide work for the worker; and

(g) every day of absence due to a strike or lockout that is not illegal and that does not continue for more than

30 days;

but shall not include the day fixed as the weekly holiday under section 24.

A worker shall be allowed and shall take the holidays to which he is entitled on consecutive days.

3. A worker shall be allowed his holiday or holidays on a day or days to be mutually agreed upon between him and his employer.

4. Where a worker leaves of his own accord or is discontinued or dismissed from employment, he shall, at the time of such leaving, discontinuance or dismissal, be paid one day's wage for each holiday to which he was entitled at the date of such leaving, discontinuance or dismissal.

5. The remuneration for each holiday shall be the average daily wage of the worker obtained by dividing the total wage (excluding overtime and bonuses) earned by the worker for the days on which he has actually worked in the last 60 days of the (excluding overtime and bonuses) earned by the worker for the days on which he has actually worked in the last 60 days of the qualifying year by the number of such days.

6. The remuneration due to a worker in respect of his holiday or holidays shall be paid to him before such holiday or holidays but not earlier than seven days before such holiday or holidays.

7. In these paragraphs, "year" means a continuous period of 12 months.

8. The foregoing decisions shall not apply in respect of employment at any time more than 12 months prior to the date on which the decisions come into force.
