LAND SETTLEMENT ORDINANCE.

Settlement Order

WHEREAS a settlement notice under section 4 of the Land Settlement Ordinance was duly published in the *Gazette* No. 8,314 of September 10, 1937, and as otherwise required by the said section, in respect of the lands situated in the village of Asmadala in the Egodapota Pattuwa of the Galboda Korale of the Kegalla District in the Province of Sabaragamuwa and described as lots 1, 2, 4, 5, 6, 7, 8, 9 and 10 in Preliminary Plan No. 4,161 (*vide* Settlement Notice No. 1,623).
