KNOW Ye that, in pursuance of the powers vested in the Governor by section 2 of the Prisons Ordinance (Chapter 44), I, John Curtois Howard, Officer Administering the Government of Ceylon, do by this Proclamation establish a Prison for this Island in the premises of the Fiscal's Lock-up at Ratnapura, for the reception of prisoners of every description committed or remanded under the authority of any Court, for the period during which the criminal sessions of the Supreme Court commencing on or about the 16th day of January, 1947, shall be holden at Ratnapura.
