Customs Notification (Tariff) No. 47/1.

IT is hereby notified that the following resolution under section 9 of the Customs Ordinance passed by the State Council at its public session on February 7, 1947, and sanctioned by the Governor, has been submitted to and sanctioned by the Secretary of State for the Colonies.

Resolution.

L. D.-CF, 11/37.

This Council resolves under section 9 of the Customs Ordinance, read with section 4 of the Export Duties (Continuation of Increased Rates) Ordinance, No. 9 of 1945— Cap. 185.

(1) that, with effect from the date on which the sanction of the Secretary of State to this

resolution is notified in the Government Gazette, export duty upon the goods severally specified in Column I. of the Schedule to this resolution shall be levied and paid at the rates prescribed in the corresponding entries in Column II. of that Schedule: of that Schedule;

(2) that, notwithstanding paragraph (1) of this resolution, export duty on any tea, which is certified under the hand of the Tea

Commissioner-

(a) to have been sold at either of the public auction sales of tea organised by the Colombo Tea Traders' Association and conducted at the Ceylon Chamber of Commerce Sales Room on the twentieth day and the twenty-seventh day of January, 1947; or

(b) to have been manufactured prior to the first day of January, 1947, and purchased by the Tea Commis-sioner on behalf of the United Kingdom Ministry of Food,

shall be leviable and payable at the rate applicable prior to midnight of the twenty-seventh day of January, 1947; and

(3) that nothing contained in this resolution shall affect any export duty on any of the goods specified in the Schedule hereto, leviable or payable under any written law (other than the Customs Ordinance, the Medical Wants Ordinance, and the Export Duties (Continuation of Increased Rates) Ordinance, No. 9 of 1945).

THE FOOD CONTROL ORDINANCE.

Order No. 134.

BY virtue of the powers vested in me by section 4 (1) (a) of the Food Control Ordinance (Chapter 132) read with the Defence (Food and Price Control) (Transfer of Powers) Regulations, 1942, and with the Supplies and Services (Transitional Powers) Order, 1946, I, Don Stephen Senanayake, Minister for Agriculture and Lands, do by this Order prohibit the transport or removal of any quantity of Red Onions from Jaffna Peninsula except under the authority of a permit issued by the Government Agent, Northern Province, Deputy Food Controller.
