The above Open General Licence is issued subject to the condition that nothing therein shall affect or prejudice, or be deemed or construed to affect or prejudice, the provisions or requirements of any other written law applicable to any goods to which such Open General Licence refers at the time of the

importation of any such goods to Ceylon.
