Every claim and every objection to the inclusion of a name in the register must reach the said Registering Officer within two weeks from the date of the publication of this notice in the Government Gazette. Every objection to the

Every objection to the insertion in the register of the name of a claimant must reach the said Registering Officer within ten days from the date of which a notice containing the names of claimants is exhibited at the Office of the said Registering Officer.
