THE REVENUE PROTECTION ORDINANCE.

THE following Order made by the Minister of Finance in pursuance of the powers vested in him by section 2 of the Revenue Protection Ordinance is hereby published for general information.

Order.

Whereas the Cabinet has, during the present Session of Parliament, approved of the introduction into the House of Representatives of a resolution whereby, if such resolution be carried, the export duty payable on the goods specified in column I of the Schedule hereto will be altered:

Now, therefore, in pursuance of the powers vested in me by section 2 of the Revenue Protection Ordinance (Chapter 191) read with the Proclamation under section 88 of the Ceylon (Constitution) Order in Council, 1946, published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Junius Richard Jayawardene, Minister of Finance, do hereby order the Principal Collector of Customs from midnight of August 12/13, 1948, to demand and to levy, on the goods specified as aforesaid in column I of that Schedule (in lieu of the export duties payable thereon under the existing law), the export duties set forth in the said resolution, that is to say, export duties at the rates set out in column II of the Schedule hereto, in addition to the export duties leviable or payable on those goods under any written law other than the Customs Ordinance:

Provided that, in every case where the Collector is satisfied—

- (a) that a valid contract for the sale of any such goods to a buyer outside Ceylon was entered into prior to 4.30 o'clock in the afternoon of the 12th day of August, 1948 (hereinafter referred to as "the relevant time"); and
- (b) that any quantity of such goods, having been purchased by the exporter prior to the relevant time for the purposes of exportation in fulfilment of that contract, is being exported in fulfilment thereof,

export duty on that quantity of such goods, or on such part thereof as represents the quantity specified in the contract, (whichever of those quantities is the less), shall be leviable and payable at the rates applicable prior to the relevant time.
