They should (a) have a degree of a recognised University preferably in Statistics or in Economics with Statistics as a subject, and (b) possess organizing ability and administrative experience so as to be able to assume charge of a large Government Department.

If the selected candidate is the holder of another pensionable appointment under Government, he will, in the first instance, be appointed to this post in an acting capacity for one year with a view to testing him in the new post. (3) The Chairman of the Rent Assessment Board shall, within seven days of the receipt by him of a petition of appeal, forward the partition to the Chairman of the Rent Assessment.

forward the petition to the Chairman of the Board of Review together with the record of proceedings before the Rent Assessment Board and all other relevant documents.

- Every petition of appeal to the Board of Review under the Ordinance shall bear uncancelled stamps of a value determined in accordance with the rates set out in the Schedule to these regulations.
- 4. The Board of Review may, in its discretion, on application made in that behalf, entertain a petition of appeal made after the expiry of the time specified in section 12A (4) of the Ordmance if the Board is satisfied that the failure to present the petition within that time was due to accident, misfortune or other unavoidable cause.
- (1) The Chairman of the Board of Review shall keep and maintain or cause to be kept and maintained a register of all petitions of appeal received by the Board, and shall, on receipt of any such petition, assign a number to the petition and cause that number to be entered in the register together with such other particulars as the Chairman may deem necessary.

(2) The Chairman of the Board of Review shall, as soon as may be after the receipt of a petition of appeal, by written notice inform the appellant and the respondent of the date on which, and the time and place at which, the petition of appeal will be heard by the Board.

(3) Every notice under paragraph (2) shall be sent by registered post not less than ten days before the date specified therein as the date on which the petition of appeal will be

therein as the date on which the petition of appear will be heard by the Board of Review.

Every such notice sent to the respondent shall be accompanied by a copy of the petition of appeal.

- 6. The Chairman of the Board of Review shall publish or cause to be published, at least once in the Gazette and in one or more newspapers, the following particulars:
  - (1) the address to which all communications to the Board should be sent; and

- 7. At the hearing of any appeal by the Board of Review no person, other than an advocate or a proctor, shall be entitled to represent any party to the appeal-
  - (a) unless he is authorised in writing in that behalf by such party; and
    (b) except with the special permission of the Board.
- 8. The Board of Review may at the hearing of any appeal under the Ordinance make an interim award as to costs against any party of an amount not exceeding one hundred rupees.
- 9. (1) The remuneration payable to each member of the Board of Review who attends a sitting of the Board shall be Rs. 50.
- (2) A travelling allowance shall also be payable to each member of the Board of Review who attends a sitting of the Board, at the rate and in accordance with the provisions, applicable in the case of members of the public service.
- 10. Subject to the provisions governing the procedure of the Board of Roview set out in the Ordinance or in any regulations made thereunder, the Board may regulate its own procedure.
  - 11. In these regulations-
  - "Board of Review" means the Board of Review established under section 12A of the Ordinance;
    "Ordinance" means the Reut Restriction Ordinance,
  - No. 60 of 1942;
  - "Ront Assessment Board" means any Rent Assessment Board established under section 11 of the Ordinanco."

(a) No refund of the examination fee will be made, but if notice of a candidate's withdrawal is received in the Surveyor-General's Office, Colombo, at least 14 days before the date of commencement of the oxamination, a voucher will be issued.
