1. Tenders which must be enclosed in sealed envelopes super-scribed "Tenders for the lease of plumbago mining rights", will be received at the Ratnapura Kachcheri until 10 A.M. on October 21, 1948, when they will be opened. All persons making tenders must be present in person, at the Ratnapura Kachcheri on the above date and time or satisfy the Government Agent by some duly accredited Agent that the tender is made in good faith.

2. The Government Agent reserves to himself the right of rejecting any or all tenders.

3. The person, whose tender is accepted shall deposit the full amount of his tender at once and a further sum, not exceeding, Rs. 1,000 (with a minimum of Rs. 100 per acre or part thereof) in respect of each block of land as may be approved by the Government Agent by way of security for the duefulfilment of the conditions on which the tender is accepted.

4. The successful tenderer shall enter into a mining lease within ten days of his being required to do so by the Government Agent. In the event of his failure to do so or of breach of any of the condi-tions on which his tender is accepted the successful tenderer shall be hable to forfeit any deposit made by him.

5. On payment of the tendered amount and sum required as security, the successful tenderer shall be entitled to enter the land and commence mining on receipt of a mining permit, pending issue of the lease

6. The lease will contain the following conditions inter alia :-

(a) the term of the lease shall be five years in the first instance, with an option of renewal of a further term of five years at the sole discretion of the lessor;

- (i) a sum calculated at five per cent. of the estimated value of the entire quantity of the plumbago won from the land, or
- (ii) a sum of Rs. 100 per acre or part of an acre whichever amount is greater.
