The tenders which must be enclosed in sealed envelopes superscribed "Tender for Boutique Site—Sripadastana Route" will be received at the Ratinapura Kachcheri, until 10 A.M. on December 1, 1948, when they will be opened and all persons making tenders will be required to be present or satisfy the Government Agent by some duly accredited agent or agents that the tender is bona fide.
