MISCELLANEOUS LAND NOTICES.

Notification under Land Sale and Lease Regulations 58 and 59.

NOTICE is hereby given that the Secretary of the Methoddam Agricultural Production and Sales Society, Ltd., Uyilankulam, has applied for a lease of lot 22 in P. P. 7,350, in extent 3 R. 9 P., situated in Uyilankulam village, Mannar District, for the purpose of constructing an office and store thereon.

2. This lot is not required for any public purpose. Its situation by the Mannar-Madawachchi road will facilitate the transport of paddy, &c. The Society, which is now in occupation of a temporary shed on private land, is in urgent need of accommodation. It is therefore proposed to lease the land to the Society subject to the following conditions, amongst others:—

(a) the term shall be 10 years, with an option of renewal for a further term of 10 years;

(b) the rent shall be Re. 1 per annum;

(d) the lessee shall use the land as a site for an office and store, and for no other purpose.
