Food Price Order No. C-206.

DRIED FISH AND DRIED PRAWNS.

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Order.

BY virtue of the powers vested in the Controller of Prices (Food) by section 3 of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Reginald Sydney Vernon Poulter, Controller of Prices (Food), do by this Order—

- (i.) revoke with effect from this date Food Price Order No. C-167 published in *Government Gazette* No. 9,777 of September 26, 1947, in so far as it has not been already revoked;
- (ii.) fix the prices specified in column 2 of the First Schedule hereto to be the importer's maximum price above which the articles specified in the corresponding entries in column 1 of that Schedule shall not be sold within the Municipal limits of the town of Colombo;
- (iii.) fix the prices specified in columns 2, 3 and 4 of the Second Schedule hereto to be respectively the maximum wholesale price per cwt. net, the maximum wholesale price per lb. net and the maximum retail price per lb. net, above which the articles specified in the corresponding entries in column 1 of that Schedule shall not be sold within the Municipal limits of the town of Colombo and the Revenue Districts of Jaffna, Vavuniya, Trincomalee, Mannar and Puttalam;
- (iv.) fix the prices which are for the time being fixed by me as the maximum wholesale price per cwt. net, the maximum wholesale price per lb. net and the maximum retail price per lb. net, for the Colombo Municipality, increased by the amounts specified in columns 2, 3 and 4 of the Third Schedule hereto to be respectively the maximum wholesale price per cwt. net, the maximum wholesale price per lb. net and the maximum retail price per lb. net, above which the articles specified in column 1 of the First Schedule hereto shall not be sold within the areas specified in the corresponding entries in column 1 of the Third Schedule hereto;
- (v.) direct that for the purposes of this Order—
 - (a) any sale of any quantity of dried fish or dried prawns for the purpose of resale, or any sale of any dried fish or dried prawns in a quantity of one whole bag or more at a time, shall be deemed to be a sale by wholesale;
 - (b) any sale of dried fish or dried prawns in a quantity less than a whole bag for any purpose other than resale shall be deemed to be a sale by retail;
 - (c) an "importer" shall mean any person in whose name any dried fish or dried prawns has been cleared from the Customs, and shall include every person who has been appointed by the Director of Food Supplies as a distributor or as an agent for the distribution of dried fish;
 - (d) a "wholesale dealer" shall mean any person who is in the habit of selling dried fish or dried prawns by wholesale;
 - (e) the "importer's maximum price" fixed for sales within the Municipal limits of the town of Colombo shall apply to the sale by wholesale of any article by an importer to a wholesale dealer;
 - (f) the "maximum wholesale price per cwt. net" fixed for sales within the Municipal limits of the town of Colombo shall apply to all sales by wholesale in whole bags, except sales by an importer to a wholesale dealer;
 - (g) the "maximum wholesale price per lb. net" fixed for sales within the Municipal limits of the town of Colombo shall apply to all sales by wholesale in quantities less than a whole bag, except sales by an importer to a wholesale dealer;
 - (h) the "maximum wholesale price per cwt. net" fixed for sales outside the Municipal limits of the town of Colombo shall apply to all sales by wholesale in whole bags;
 - (i) the "maximum wholesale price per lb. net" fixed for sales outside the Municipal limits of the Town of Colombo shall apply to all sales by wholesale in quantities less than a whole bag;
 - (j) the "maximum retail price" shall apply to all sales by retail;
 - (k) a "whole bag" shall mean a bag or bundle or crate filled with dried fish or dried prawns;
 - (l) "dried fish" shall be deemed to be the same as "dry fish";
 - (m) "Town area" shall mean, at places where Sanitary Boards formerly existed, the former Sanitary Board area;
- (vi.) direct that in every area where maximum prices are fixed by this Order no trader shall sell any article specified in column 1 of the First Schedule hereto which is adulterated with any other article or with an article of an inferior description or grade or quality;
- (vii.) direct that in every area where maximum prices are fixed by this Order every trader, who has in his possession at any premises any article specified in column 1 of the First Schedule hereto, shall exhibit in a conspicuous position at those premises a notice in which there shall be set out the maximum prices fixed by this Order in respect of that article;
- (viii.) direct that in every area where maximum prices are fixed by this Order every trader, who at any premises has been in the habit of selling any article specified in column 1 of the First Schedule hereto and has for the time being no stocks of that article for sale, shall exhibit in a conspicuous position at those premises for a period of three months from the date he last sold that article a notice to the effect that he has no stocks of that article available for sale for the time being;
- (ix.) direct that in every area where maximum prices are fixed by this Order every person who sells by wholesale any article specified in column 1 of the First Schedule shall, and every person who sells by retail

any article specified in column 1 of the First Schedule shall on demand, give the purchaser of that article a receipt in which there shall be set out—

- (a) the date of sale ;
 (b) the description of the article sold ;
 (c) the weight of the quantity sold ;
 (d) the price paid for the quantity sold ; and
 (e) the nature of the transaction, that is to say whether the sale was by wholesale or by retail.
