THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Revocation Order.

BY virtue of the powers vested in me by section 3 of the Control of Prices Ordinance, No. 39 of 1939, as amended by Defence (Control of Prices) (Supplementary Provisions No. 2) Regulations, I, Maximus Lucian Dido Caspersz, Controller of Prices (Food), do by this Order revoke with effect from this

date, Food Price Order No. C-160 published in Government Gazette No. 9,746 of August 8, 1947, and Food Price Order No. C-192 published in Government Gazette No. 9,845 of March 24, 1948, in so far as they fix maximum prices for BOMBAY ONIONS in all parts of Ceylon.
