THE URBAN COUNCILS ORDINANCE, No. 61 OF 1939.

*Special Water Rate for 1948.*

IT is hereby notified that—

- (a) the resolution of the Talawakelle-Lindula Urban Council imposing for 1948 the special water rate specified in the notification published in *Gazette* No. 9,863 of May 14, 1948, has, in so far as it relates to the period October 1 to December 31, 1948, been rescinded; and
- (b) the Talawakelle-Lindula Urban Council has, under section 143 (b) of the Urban Councils Ordinance, No. 61 of 1939, and with the sanction of the Minister of Health and Local Government given by virtue of the powers vested in him by that section, as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, imposed for the period October 1 to December 31, 1948, subject to such limits and exemptions as may be prescribed by by-laws, a special water rate of eight

per centum of the annual value of all immovable property situated within the area which is benefited by the water service and which is specified in the Schedule hereto.
