

Abstract.-

The invention relates to improvements in the subject matter of Coylon Patent Specification No. 3,404. In the earlier patent a fusible mixture containing an ethylene exide derivative of a phenol containing at least two ethylene exide groups and a hardening agent is melted and applied to the surfaces, and the bond is formed by the application of heat. The present invention is to overcome the difficulty of previously melting the mixture, by substituting a mixture which is capable of being spread at ordinary temperatures.

A resinous oxide derivative may be one which is capable of being spread at ordinary temperature, and to the mixture may be added a liquid which is non volatile under the conditions of the process; alternatively, the derivative may be one which is solid and a liquid hardening agent may be used which is non-volatile; a further alternative is that in which both derivative and hardening agent are solids, and one used with a liquid which is non-volatile under the conditions of the process. Among the substances used may be a resinous ethylene oxide derivative of a polynuclear phenol of which the nucli are connected by a carbon bridge.
