NOTIFICATIONS UNDER "THE PATENTS ORDINANCE, 1906."

THE following Specification has been accepted:—

No. 3,488 of September 17, 1947. (Date applied for under Section 48 of the Ordinance, May 28, 1946).

"Improvements in and relating to valve taps and faucets".

Abstract.—

The inventor describes a renewable seating piece adapted for fitting to the valve controlled passage and port in the body or housing of a cock, tap or valve comprising a perforated disc or washer furnished on one face with a tubular shank which forms an extension of the perforation or bore and terminates at its free end in coned compressible and resilient external collar. When this washer is fitted a rigid reinforcing bush or liner can be pushed into the bore to keep the washer in place. If the seating piece is made of relatively rigid resilient material, the tubular shank and external collar are longitudinally slotted, to enable the seating piece to be pushed into the port in the housing.

There are 5 claims and 2 sheets of drawings.
