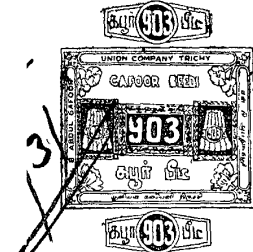

### NOTIFICATIONS UNDER "THE PATENTS ORDINANCE, 1906."

THE following specification has been accepted:—

No. 3,491 of September 24, 1947.

*Murugupillai Navaratnasamy.*

"A machine for drilling and spacing seeds."

*Abstract.*—The invention relates to a two-wheeled cart equipped with (a) seed boxes which can be arranged transversely at any desired spacing, (b) detachable seed wheels with circumferential cavities driven by the axle for transferring the seed from the boxes to the stoppers, (c) stoppers periodically actuated through a lever by the spokes of the wheels to release the seed at predetermined intervals, and (d) automatic clutches which prevent seed wheels moving on the reverse motion of the wheels.

It is possible to have one set of stoppers actuated by the spokes of one wheel while the other set are actuated by the spokes of the other, so that one can have a mixed crop of say green gram spaced 1 foot apart in the row, and cowpea spaced 2 feet apart. Drilling of one variety of seed with spacing of another is also possible.

There are 5 claims and 5 sheets of drawings.
