(1) The following trades shall be deemed to be offensive trades.

- Manufacture of compost or artificial manure.
- Manufacture of vinegar. (h
- Manufacture of soap (0

- (q) Curing of manufacture of rubber (h) loing of fish

 (l) Storing of hides
- (m) Storing of bones
- Storing artificial manure or materials used for the preparation of artificial manure in quantity over three bags
- Storing of cured or dry fish. Storing of perishable articles of food for the pur-pose of trade by wholesale. (p)

(2) The following trades shall be deemed to be dangerous trades.

- (a) Any trade in which machinely driven by oil or other fuel, steam or electricity is used
- Burning or storing of lime.
- Curing or storing of plumbago (d)
- Digging for coral stones by opening a pit
- Extraction of oil by apparatus (f) Manufacture of coconut oil by machinery
- Manufacture of copra.
- (g) Manufacture of copra. (h) Manufacture of aerated waters.
- (i) Manufacture of desiccated coconut (j) Manufacture or storing of fibie.
- Manufacture of matches.
- (l) Quarrying for cabook, gravel or metal
- (m) Storing of copra (n) Storing of straw
- (o) Storing of cotton wool.
- (3) The following trades shall be deemed to be offensive and dangerous trades
- (a) Burning of bricks and tiles;

(b) Dyeing fibre

2 (1) No person shall carry on any offensive or dangerous trade unless he is the holder of a licence issued in that behalf by the Chairman on the recommendation ot the Medical Öfficer of Health.

2) Every licence shall, unless it is earlier cancelled under by-law 14, expire on the thirty-first day of December of the year in respect of which it is issued

(3) No licence shall be transferable

No person shall be entitled to a licence to quarry 3 metal unless he has provided separate latrines for male and female workers at the quarry Without prejudice to the preceding provisions of this by-law, no person shall be entitled to a licence to carry on any offensive or dangerous trade unless-

(1) the place at which that trade is to be carried on 15 approved by the Medical Officer of Health, and

(2) every building to be used for the purposes of that trade is in conformity with the following requirements

- (a) the building must be in good repair, well venti-lated, well lighted, and provided with adequate
- dramage and latrine accommodation, (b) the roof of the building must be made of some permanent material and the floor must be cemented,
- (c) the eaves of the building must be not less than six feet from the ground,
- (d) every room in the building must be provided with windows capable of being opened and the area of such windows when open shall be not less than one-fifteenth of the superficial floor space,
- (c) the walls of every room in the building must be not less than seven feet in height and must
- be built of brick, stone or cabook, (f) the internal surface of such walls, to a height of at least four feet from the floor, must be plastered with cement and the rest of the walls must be
- lime-plastered and lime-washed, and (g) the woodwork of the building must be oil-painted or lime-washed

(1) If at any time during the period for which a licence has been issued in respect of any offensive or dangerous trade any building used for the purposes of that trade ceases to conform to the provisions of by-law 3, the Chairman may, on the recommendation of the Medical Officer of Health, cause a notice to be served on the holder of the licence requiring him to do before a day specified in the notice, all things necessary to make such building conform to such provisions

(2) No holder of a licence to carry on any offensive or dangerous trade on whom a notice is served under para-graph (1) shall fail to comply with the requirements of such notice within the time specified therein

5 Any notice under by-law 4 shall be deemed to "have been served on the holder of a heence to carry on any offensive or dangerous trade if it is affixed to the premises at which he carries on that trade or if it is left with any person employed by him in such premises

- (1) The holder of a licence to quarry metal shall 6
- (a) keep the premises in a clean and sanitary condition,
- maintain order within the licensed premises, and (b)
- not permit gambling or disorderly conduct in the (c) licensed premises

(2) The Chanman may, during the continuance of an epidemic, suspend any licence to quary metal if the suspension is necessary in the interests of public health

The holder of a licence to burn bricks or tiles shall take all necessary steps to ensure that-

- (a) the premises where clay pits are being dug are fenced.
- (b) no obstruction is caused to any village load or path during the loading or unloading of bricks, tiles or firewood, and
- (c) at least one watcher is kept on duty while bricks or tiles are being burnt

8 The holder of a licence to carry on any offensive or dangerous trade shall cause-

- (a) the floor of every building used for the purposes of such trade to be swept and cleaned daily,
- (b) the walls of every such building to be lime-washed at least once in every twelve months,
- (c) all apparatus, implements, and vessels used in such trade to be kept clean, and
- (d) all refuse, sweepings, scrapings and waste and by-products which are not to be subjected to further trade processes to be removed daily in covered receptacles from the premises in which such trade is carried on.

No holder of a licence to carry on any offensive or dangelous trade shall contaminate any well, tank, river, stream, canal, channel, lake or other inland water

10 No holder of a licence to carry on any offensive or dangerous trade shall carry on such trade m any manner likely to cause a nuisance to or to be injunious to the health or comfort of persons in the neighbourhood

Every holder of a licence to carry on any offensive or dangerous trade shall cause any offensive vapours or gases which are emitted in the course of carrying on such trade-

- (a) to be discharged into the external air in such a manner and at such a height as to admit of their diffusion without injurious or offensive effect; or
- (b) to be passed directly through a fire or into a condensing apparatus.

It shall be lawful for the Chairman, of the 12 Medical Officer of Health, or the Sanitary Inspector or any other officer of the Committee authorised in writing by the Chairman, at all reasonable times to enter upon and inspect any premises at which any offensive or dangerous trade is being carried on, and the holder of the licence or person in charge thereof shall permit the inspection to be made

13 The holder of a licence to carry on any offensive or dangerous trade shall keep affixed in a conspicuous position on the premises in which such trade is carried on, the licence obtained under by-law 2, or where such licence cannot be affixed cause a board to be affixed, with the licence number and the name of the holder of the licence clearly painted thereon, in a conspicuous place on such premises

It shall be lawful for the Rural Court in addition 14 to any other punishment that it may impose, to cancel the licence of any holder of a licence convicted twice or oftener of a breach of any of the by-laws relating to offensive or dangerous trades, and the holder of the licence shall not be entitled to any compensation in respect of the cancellation

In these by-laws " Chairman " means the Chair-15 nan of the Village Committee of the Uduvil village area.
