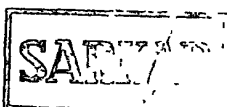

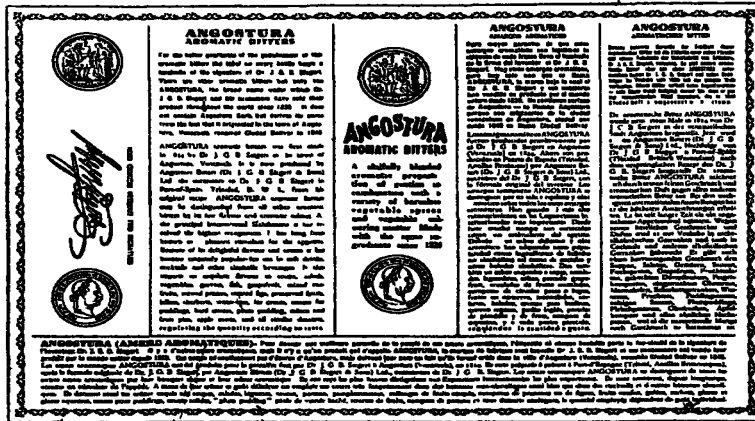

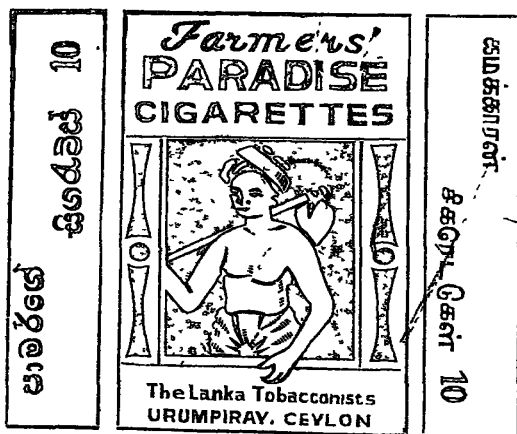

Archibald Milne Hamilton and British Insulated Callender's Cables, Ltd.

"Improvements in and relating to buildings"

Abstract.—The invention relates to large structures (aero-plane hangers and the like) built of standard parts of box girder construction. It has been found that where the roof sections are of constant depth the deflection and chord stresses at the centre limits the span of the building.

The present invention seeks to overcome this disadvantage by providing upper chord sloping at a small inclination and a horizontal or nearly horizontal lower chord. The stanchions are as before constructed with constant depth between chords and may be hinged or rigidly connected to the roof portion. At the deeper portion of the truss lattice bracing between chords is adopted.

According to a modification the truss is formed of a roof portion of box girder construction of even depth and a horizontal lower chord attached by a series of verticals of graduated lengths. Additional features are described and claimed.

"Improvements in or relating to apparatus for feeding gramophone records to a turn-table"

Abstract.—The inventor seeks to eliminate the pusher mechanism operating on the periphery of the records in a record changer. According to the invention, the record pillar

is provided with a shoulder and eccentric portion for the stack of records. Mounted for rotation on the record post is a sleeve with a projection whose height is slightly less than the thickness of a record, the level of the remainder of the top of the sleeve being slightly below the shoulder. The movement for dropping a record from the stack is initiated by the sleeve moving counterclockwise till the projection engages the hole in the lowermost record and then moving clockwise to shift the record laterally to bring into a concentric position with respect to the record post. The sleeve is spring loaded so as to avoid taking the weight of the stack on the projection of the sleeve. The shoulder portion of the record post together with the extension are detachable to enable the record to be removed from the turn-table after the last record has been played.

Abstract.—The object of the invention is to prevent the material sticking to the wall of the kiln by fusing when clay is burnt in a rotary kiln for producing a light weight aggregate. The inventor describes a method of producing a material of cellular structure suitable for insulating purposes by burning clays or similar silicates in a rotary kiln characterised in that the raw material to which may be added substances which will burn away during the burning process and thereby improving the tendency of the formation of a cellular or porous structure, is introduced in a rotary kiln rotating with a number of revolutions which is essentially greater, for example, double the number of revolutions of a rotary kiln of corresponding diameter for burning portland cement. Preferably the peripheral speed of internal surface of the kiln is 13 yards per minute. The substances added to the clay may be water soluble, including colloid soluble non-volatile industrial waste products such as lignine decomposition products or molasses. Projections are provided in the lining of the kiln for lifting the material and dropping it into the burning zone of the kiln.
