NOTIFICATIONS UNDER "THE PATENTS ORDINANCE, 1906"

THE following specification has been accepted :-

Arthur Cyril Kempitiya.

"A protective device for mudguards of motor vehicles ".

Abstract.—The object of the invention can be ascertained from the single claim which is as follows:— A device for protecting the mudguards of motor vehicles characterised in that a detachable strip of rubber or the like is suspended along and below the undersurface of the mudguard; said strip being held in position by being passed through slits in a plurality of stays fitted across, and corresponding in shape and length to the cross-section of the mudguard and which said stays are permanently and rigidly fitted either singly or jointly by means of a connecting strip to the inner side of the mudguard or other convenient part of the vehicle, such that the stays beyond their connected ends lie away from the mudguard.
