"Improvements in and relating to machines for cutting paper webs or strips".

Abstract -The nature of the invention can be ascertained from claims 1 and 2 which are as follows

- A self-contained cutting unit adapted for dealing with continuous stationery packs of the kind referred to and comprising means for automatically and intermittently feeding the web from a pack of stationery beneath a guillotine cutter and means for operating the cutter in and means for operating the cutter in synchionism with the web feed so that the cutter operates upon the web when the latter is stationary at the points at which the cuts are to be made
- A self-contained cutting unit according to claim 1 wherein means are provided for automatically and positively holding the strips, or some of them, together at or about the cutting point while each cut is made and flattening the creases and subsequently releasing them after the cut has been made

'Improvements in or relating to means for fumigating with Pesticidal Compounds

Abstract -The inventors claim a safety tuse cold in which one or more of the textile yarn coverings around the powder core are coated or impregnated with a thermally vaporisable pesticidal compound. Preferably the coverings so treated are prevented from direct contact with the powder core by at least another wrapping of textile yarn covering. The pesticidal compound used may be a solid compound of organic nature for instance a benzene hydrochloride or a chlorinated aromatic hydrocarbon derivative

"Improvements in or relating to Fumigation and Fumigating Charges

Abstract -The invention is based on the principle that when a mass of ammonium nitrate mixed with a salt of chromic acid, e g potassium bichromate is strongly heated at a point by means of a red hot object, a selfsustained flameless gas producing exothermic reaction progresses through the mass at ordinary pressure temperatures produced are generally speaking much

below those experienced in ordinary combustion
The invention consists in adding pesticidal compounds, eg, D D T to the above mixture, with china clay and binding compound and compressing the mixture in the form of a candle A small piece of igniting composition is stuck on the top of the candles a candle is ignited it emits a fume comprising an aerosol of the condensed vapour of the pesticide. This candle is safe to use in confined space even when other ignitable articles are present

"Improvements relating to Gramophone Records

Abstract —The nature of the invention can be ascertained from claims 1 and 2 which are as follows -

A gramophone record which comprises shellac as a thermoplastic ingredient, and a bituminous substance whereby wax separation from the shellac which is liable to occur during manufacture of the record, is substantially prevented

Material for manufacturing gramophone records which comprises from about 20 to about 30 per cent by weight of shellac, and a bituminous substance to an amount not exceeding 1 per cent by weight of the material, said bituminous substance being capable of substantially preventing wax separation from the shellac which is liable to occur during the manufacture of the records

"Double headed Match"

Abstract -The nature of the invention can be asceitained from claims 1, 2 and 3 which are as follows. --

- A double headed match of approximately normal match length characterised in that the match stick is shaped to provide an enlarged centre part notched or scored midway for easy severance of the chaired portion after ignition, the said enlarged centre part being rendered noninflammable by impregnation with fireproofing chemicals
- Double headed match as claimed in claim 1 wherein the enlargement of the centre part is obtained by passage through pressure rollers which may also serve to apply non-inflammable material thereto
- Double headed matches as claimed in claims 1 & 2 produced from a blank with the enlarged parts in staggered relationship to save wastage of material, the lateral edges of the enlarged centre part being bent over to strengthen the longitudinal median part of the match

"Improvements in and relating to collapsable tubes

Abstract —The invention relates to the discharging ends of collapsable tubes—Such tubes are provided with a nozzle which has a screw-threaded portion for engagement with a cap According to the invention a recess or a plurality of recesses is provided in the nozzle at a point remote from the discharge end of such a depth that they provide shoulder or shoulders whereby engagement of the tube may be secured with an element which

may be a bifurcated arm forming part of the dispensing device in order to enable a fluid-tight joint to be secured between the nozzle element and a member of such device provided with a passage through which fluid may be de-livered. The fluid-tight joint is obtained by pressing the sharp peripheral edge of a hollow element which is part of the dispensing device into the face of the nozzle which is provided with a seating of sufficient area and thickness for the purpose Suitable arrangements are described for clamping the dispensing device to the end of the tube The dispensing device comprises a pump for exhausting the tube. An adapter is also described and claimed for attachment to a tube not provided with a nozzle of the manner described
