NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Commercial purpose, Mr. Loku Kamadi Hennedi Nandana Rathnasiri has requested on lease about 02 Roods, 30.5 Perches out of extent marked Lot No.- as depicted in the Tracing No. - and situated in the Village of Bendiwewa with belongs to the Grama Niladhari Division of No. 154, Samudragama coming within the area of Authority of Thamankaduwa Divisional Secretariat in the District of Polonnaruwa.

02. Given below are the boundaries of the land requested :

On the North by : Main Road Reservation ;
On the East by : Land of Mr. Ananda Kumarasiri;
On the South by : Residential Land of Mr. L. K. H.
N. Rathnasiri;
On the West by : Land of Samurdhi Bank.

The land requested can be given on lease for the necessary purpose. Therefore the Government has intended to lease out the land subject to other Government approved conditions and the following conditions :

(a) *Terms of the lease* .- Thirty (30) Years (15.06.1995 on wards);

The annual rent of the lease .- 4% of the commercial value of the land as per valuation of the Chief Valuer for the Year 1995. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not more than 50% of the amount that just preceded.

Penalty.- Treble 4% of the developed value of the land ;

- (b) The lessees must, within one year of the commencement of the lease, develop the said land in such a manner as to captivate the mind of the Divisional Secretary;
- (c) The lessees must not use this land for any purpose other than for the Commercial purpose;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions;
- (e) The Buildings Constructed must be maintained in a proper state of repair;
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained action will be taken to terminate the lease;
- (g) No sub-leasing can be done until the expiry of a minimum period of 05 years from 30.04.2012;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this notice is published in the *Gazette* to the effect that this land must not be given on lease, the land will be leased out as requested.
