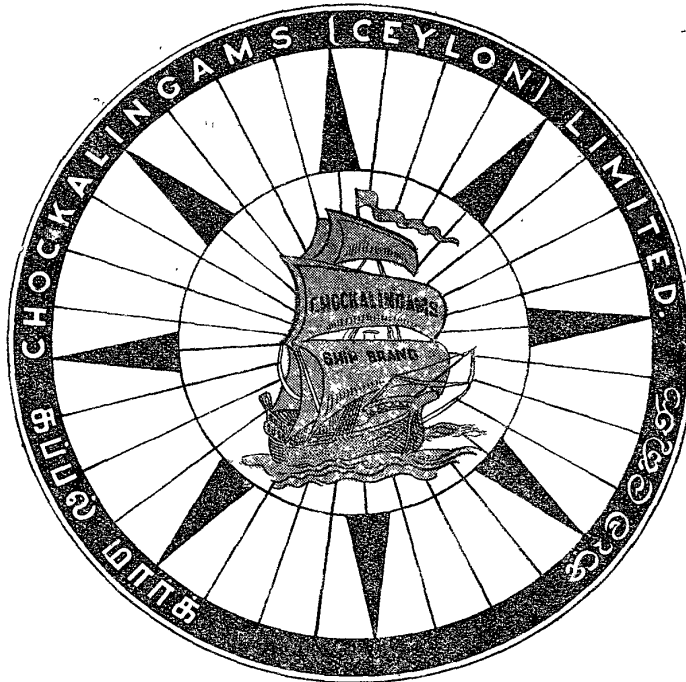

Notifications under "The Patents Ordinance, 1906"

THE following specification has been accepted:—

No. 3,618 of March 30, 1949. (Date applied for under Section 48 of the Ordinance, April 1, 1948.)

Lever Brothers & Unilever Limited.

"Improvements in the manufacture of margarine."

Abstract:—The object of the invention is to increase the thinness or "spreadability" of margarine. In the known process liquid fat is mixed with aqueous ingre-

dients in the required proportion and subjected to simultaneous emulsification and rapid chilling in a "votator". Margarine produced by such means is apt to be "thick". The inventors state that this undesirable quality can be reduced by precooling and agitating the fat whereby the higher melting point constituents separate out first before the mixture is pumped into the votator. The agitation of the mass is performed by a "precrystallisation" which comprises a shaft provided with a series of rods rotating inside a drum with fixed rods.

Suitable arrangement of plant for carrying out the above process in a continuous manner is described. The inventor states that in the finally solidified margarine the fat components which have been "precrystallised" are embedded in a matrix of minute crystals of the lower melting point constituents (and entraining the liquid components of the margarine) which readily melts in the mouth.

"Improvements in the manufacture of margarine"

Abstract:—The object of the invention is to "homogenising" the chilled and emulsified material leaving the votator before it has completely set, by passing it as a continuous stream through one or more mesh screens and, after passage through each screen and before passage through a subsequent screen, causing it to undergo a sudden change in its direction of flow, for example through a right angle, the material then being allowed to set to its final consistency with the minimum of interference by forces liable to cause shearing therein.

The process is claimed singly or in conjunction with the precrystallising process claimed in Ceylon Application No. 3,618.
