## Notifications under "The Patents Ordinance, 1906"

Societe Des Usines Chimiques Rhone-Poulenc.

"Improvements in or relating to the production of salts of substituted Cyanamide and substituted Guanidine".

Abstract:—p-chlorophenyl cyanamide and isopropyl guanidine or a salt thereof are reacted together, preferably in an aqueous medium, the temperature of reaction being prevented from exceeding 35°C. Where a salt of the guanidine compound is employed, the reaction should be conducted in the presence of the stoichiometric quantity of a caustic alkali.

Separation of the p-chlorophenyl cyanamide-isopropyl guanidine salt presents no difficulties on account of the fact that it is insoluable in saturated solutions of alkali metal salts. Subsequent purification yields white crystals melting (with partial decomposition) at 107.5°C. It isomerises on heating to from N¹-p-chlorophenyl-N⁵-isopropyl-biguanide which is a valuable antimalaria drug.

Societe Des Usines Chimiques Rhone-Poulenc.

"Improvements in or relating to the production of N'-Chlorophenyl-N<sup>3</sup>-Isopropyl Biguande".

Abstract:—The isomerisation of the p-chlorophenyl cyanamide salt of isopropyl guanadine to N¹-p-chlorophenyl-N⁵-isopropyl biguanide is effected by heating it either dry or in suspension in a medium which is not a solvent for the salt or for the N¹-p-chlorophenyl-N⁵-isopropyl biguanide. The isomerisation may preferably be effected in a medium which is not a solvent for the salt but which is a solvent for the N¹-p-chlorophenyl-N⁵-isopropyl biguanide. Non-polar solvents of this type such as toluene or other similar high boiling non-polar solvent may be used near its boiling point whereby the tendency for the production of secondary products is much reduced.

There are 4 examples and 8 claims.
