"Neutralizing the natural yellow colouring in rubber and latex; and the neutralization of any colour in any

natural or artificial product by the use of complementary colours.  $\lq\lq$ 

Abstract —The long known principle of complementary colours, viz., that any colour can be made white by the addition of one or more colours, is made use of in this process for the neutralization of the yellow colour of natural rubber latex. Thus the yellow colouration is corrected to a workable minimum by the use of a very dilute solution of blue and violet dyes or a bluish violet dye. The slight excess yellow colouration is then offset by the use of a very small percentage of ultra violet absorbing materials, for example, such as those belonging to the dihydroxy coumarins.

The principle applies to all yellow natural or artificial products. Although a water soluble dye resistant to the action of strong solutions of sodium bisulphite and acetic acid is preferable, water insoluble dyes made into suitable dispersions can be used provided the dyes are resistant to bisulphite and acetic acid. The principle may also be extended for application to the neutralization of any colour, speck or stain in any artificial or natural product.
