





" String-hopper machine ".

Abstract.—A machine is described incorporating devices for continuously mixing flour and water and extruding the paste in the form of strings to which a slight twist is given. Endless chain conveyors of sufficient length and number are fitted inside a steaming chamber to carry the strings which are cooked in the process A cutter actuated by a cam and spring cuts the strings at regular intervals as they emerge from the exit thereby giving square string hoppers.
