"Improvement in apparatus for withering tea leaf".  
*Abstract:*—The invention relates to improvements and consists of attachments fitted at and along the backs of scooping devices described in applicant's patent No. 3,545. The attachments help to accelerate the process of wither by providing for additional tumbling or cascading of leaf. There is one claim and one sheet of drawings.

THE following specification has been accepted:—

"An improved method of and apparatus for withering tea leaf."

*Abstract:*—The invention relates to an improved method and apparatus for withering tea leaf. A drum of circular or polygonal cross-section placed horizontally is used as a withering chamber. The drum is in three sections, the two end sections being attached to internal longitudinal frame members while the centre section is held in position by independent supports unattached to the end sections. By the rotation of the end sections the tea leaf is circulated in the withering medium which is conditioned air which may enter or leave the drum through suitable apertures in the stationary middle section of the drum. Scooping devices as described in Ceylon Patent 3,545 may be attached to a rotatable shaft which can be fitted through the centre of the drum for increased tumbling action to aerate the leaf, if required. Air apertures are provided in the peripheral wall of the stationary centre section and ends of the drum. Doors for feeding and discharging leaf are provided in all three sections; any form of apparatus which generates heat or artificial light may be embodied in the peripheral wall.
