### NOTIFICATION UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that Advanced Technological Institute has requested the state land allotment in extent of 0.6052 Ha. depicted as Lot No. 01 in the plan P. P. Mada 2388 and situated in the village of Selvanagar in 157 A, Selvanagar Grama Niladhari division which belongs to Manmunai Pattu Divisional Secretary's Division in the District of Batticaloa on lease.

- (a) The lessees must not use this land for any purpose what so ever other than for educational Purposes;
- (b) The lessees must, within a period of one (01) year from the date of commencement of the lease, develop the said land, to the satisfaction of the Divisional Secretary;

(c) This lease shall also be subject to the other special conditions imposed by the Divisional Secretary and other institutes;

(d) Constructed buildings must be maintained in a proper state of repair;

(e) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time steps will be taken to cancel the agreement of lease;

(g) No permission will be granted until expiry of 05 years from the date of 02.05.2017 for any subleasing or assigning other than subleasing or assigning to substantiate the purpose of which the land was obtained ;

(h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of herein Gazette publication to the effect that this land must not be given on lease, the land will be leased out as requested.
